

1. Department of History

The term of Prof.D.R.Syiemlieh as Head of the Department of History will expire on 19.12.2005 and as such, next Head of the Department is required to be appointed. In terms of the provision under Statute 7(1) of the NEHU Act 1973. The Head of the Department shall be appointed by the Executive Council on the recommendation of the Vice Chancellor. Prof.(Mrs.) M.Sharma and Prof.(Mrs)M.Momin joined as Professoor on the same date i.e on 11.04.02. As such, the seniority shall be determined according to the date of joining in NEHU in the previous cadre(s) .Service(s) rendered in any organization shall not count for seniority in NEHU. This is as per the Executive Council's resolution No.EC:119:2004:6:6(iii) in its 119th meeting held on 20.8.2004. Prof.(Mrs) M.Momin joined the University as Lecturer on 11.6.79 and as Reader on 11.6.87 whereas Prof.(Mrs.) M.Sharma joined as Lecturer on 1.7.89 and as Reader on 18.8.93.

From the above dates of joining in the respective cadre, Prof. (Mrs) M.Momin is senior to Prof. (Mrs.) M.Sharma, therefore, the Vice Chancellor under Statute 7(1) of the NEHU Act, 1973 recommends that Prof. (Mrs.) M.Momin may be considered for appointment as Head, Department of History for a period of 3 years.

ANNEXURE-B2. Department of Political Science

In terms of the provision laid down under Statute 7(1) of the NEHU Act 1973, Prof. R.L.Walli was appointed as Head of the Department of Political Science vide Executive Council's resolution No.EC:120:2004:6:2(i) for a period of 3 years w.e.f the date he assumes office or till his superannuation whichever is earlier. Here, the incumbent will complete his term during winter vacations i.e., in between the end and beginning of the academic session. The next academic session will begin from 19th February 2006.

**Acceptance of technical resignation tendered by
Dr.K.C. Baral, Reader, Department of English,
NEHU, Shillong.**

Dr. K.C. Baral was appointed as Lecturer in English NEHU, Mizoram Campus and subsequently joined as Reader in the department of English, Shillong Campus, with effect from 1.7.91 and confirmed in the said post.

Thereafter, Dr. Baral was granted lien for a period of 2 (two) years with effect from 11.8.99(AN) vide ANNEXURE 'A' to enable him to join the post of Professor at C.I.E.F.L. Regional Centre, Shillong and he was accordingly released from the University with effect from 11.8.99 (AN).

Dr. Baral, then joined C.I.E.F.L. Regional Centre as Professor cum Director on 12.8.99 and before the expiry of the term of lien i.e., 11.8.2001, Dr. Baral made a request to the University to extend the period of lien for another year till 11th August 2002. He was further granted lien for a period of one year with effect from 11.8.2001 to 11.8.2002. (ANNEXURE 'B').

On expiry of the term of lien on 11.8.02, Dr. K.C. Baral tendered his technical resignation from the post of Reader in NEHU. (ANNEXURE 'C').

In this context, the Registrar C.I.E.F.L. Hyderabad was requested to confirm the date of Dr. Baral's permanent absorption in C.I.E.F.L. so as to enable this University to process the technical resignation of Dr. Baral. The Registrar C.I.E.F.L.(vide ANNEXURE 'D') had intimated this University that the confirmation of services of Dr. Baral would be considered subject to receipt of final relieving orders vis-à-vis termination of lien held by Dr. Baral with NEHU.

The Registrar C.I.E.F.L. was then informed that in terms of provision of FR 14 technical resignation of Dr. Baral cannot be accepted unless the order of Dr. Baral's permanent absorption is received and a request has been made to issue necessary orders to this effect.(ANNEXURE 'E').

The Registrar C.I.E.F.L. vide ANNEXURE 'F' conveyed that Dr. Baral has been confirmed as "Approved Probationer with effect from 12.8.2000.

Accordingly, Dr. K.C. Baral has tendered his technical resignation from the post held by him in NEHU with effect from 12.8.2000, vide ANNEXURE 'G'.

Meanwhile, no dues certificates have also been obtained from the concerned Departments/Section and there seem to be no outstanding dues against Dr. K.C. Baral.

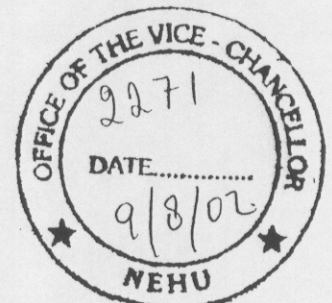


