- (i) Payment of remuneration to Non-Statutory Group-A Officers – consideration thereof.

The Executive Council at its 134th meeting held on 18.6.2008 had approved the remuneration rates in respect of teachers for holding additional responsibilities in addition to their normal duties. The said Council had also resolved to grant remuneration of Rs. 2,000/- per month to the Statutory Officers of the University, such as, Registrar, Controller of Examinations and Finance Officers, if they hold more than one position, in addition to their normal duties for more than one month continuously. But so far, there has been no remuneration prescribed for the Non-Statutory Group-A officers for holding additional responsibilities.

It is pertinent to mention herein that, over the years the administrative and academic activities of the University have increased by manifold and for which the additional responsibility are being assigned to various officers from time to time. In the recent past, consequent upon the retirement of Dr S.N.Rai, Director, Computer Centre w.e.f 31.1.2008, Shri P.P.Dey, Senior System Analyst was made In-charge of the Computer Centre w.e.f 1.2.2008-17.8.08 and for which, he has requested the University to sanction him some additional benefit. The copy of the letter dated 1.5.2008 received from Shri P.P.Dey may be seen at **Annexure-A**.
