The Ministry of Human Resource Development's letter No.F.1-22/97-U.1 of 6th November,1998 indicating the revised Scale of Pay of teachers in Central Universities on the recommendations of the Fifth Central Pay Commission was placed in the 59th meeting of the Academic Council held on 19th & 20th November,1998 and the Council after deliberating on the issue accepted the same with certain amendment and also authorised the Vice-Chancellor to amend the Ordinances. The proposed amendment of the table under Clause 2 of Ordinance OE-5 is placed as annexure 'A'. The revised Scales will be effective from 1st January 1996. Other provisions of the Clause shall remain the same.
