I am submitting this resignation letter now as I am required to give three months' notice prior to my resignation, as per the University norms.

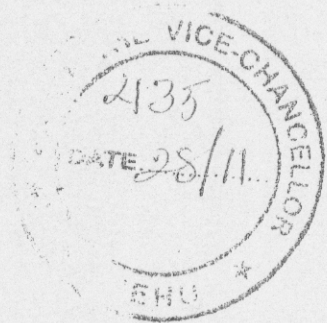
I would like to thank you for having given me an opportunity to serve the University as a teacher in the department of Mathematics. It has been a learning experience for me, and I am grateful for it.




