

- (iii) Regional para medical and Nursing Training Institute Aizawl.

The Regional Para Medical and Nursing Training Institute, Aizawl has been established with due approval of Government of India through NEC, Shillong for all the seven North Eastern States. The management of the Institute is under the Board of Governors and Executive Council where Secretary, Health, Joint Secretary, Home, Joint Secretary, Finance and Director General of Health Services, etc. of Government of India are the members. The Institute has adopted the course for B.Sc. Nursing prescribed by Indian Nursing Council. It may be noted that the students passing out from the Institute must registered themselves under Nursing Indian Council for practising licence in Nursing profession. The students will be eligible to appear the examination if the Institute is affiliated to the University i.e. to NEHU.

The matter was placed before the Academic Council in its 56th meeting held on 21st and 22nd November, 1997 which resolved to approve the same. However, the Syllabus for the Institute's Course is to be examined by a Committee consisting of the following and the Vice-Chancellor is authorised to take action on the Committee's report :
