above and to request the University to suspend the operation of  
the proposed Ordinance. Section-27 read with Statute 42 framed  
under NEHU Act, 1973 defines the scope of regulations. This  
definition precludes the scope of framing Regulations for  
laying down conditions of reemployment of retired teachers.  
The proposed amendment to clause 9 of Ordinance OE-5 is, there-  
fore, not found to be statutorily in order.
