(ix) Resignation of Shri S.Ghosh, System Analyst, Computer Centre.

Shri. S. Ghosh joined this University as System Analyst, Computer Centre w.e.f. 02.11.1991(FN) subsequently, he had applied for the post of Asstt. Professor at Durgapur Institute of Advanced Technology & Management, through proper channel.

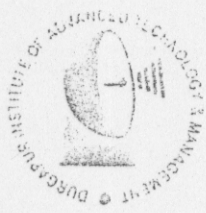
On having appointed against the said post, Shri. Ghosh had requested the University to grant him lien for a period of 2 (two) years. However, lien for a period of 1 (one) year was considered by the University effecting from 24.01.2005(AN). On expiry of the period of lien, Shri. Ghosh requested the University to grant him lien for a further period of 1 year w.e.f. 24.01.2006. But before considering the request of Shri. Ghosh, the University took up the matter with the Director, Durgapur Institute of Advanced Technology & Management, so as to know the status of confirmation of service of Shri. Ghosh at the said Institute since Shri. Ghosh was placed under probation for a period of 1 year.

Meanwhile, the Director, Durgapur Institute of Advanced Technology & Management, vide his letter No.DIATM/DIR/57 dated 03.04.2006 Vide (Annexure-A) conveyed that Shri. Ghosh has been confirmed in the post of Asstt. Professor w.e.f. 01.02.2006. After having confirm in the post of Asstt. Professor at Durgapur Institute of Advanced Technology & Management, Shri. S. Ghosh tendered his resignation from the post held by him in NEHU w.e.f. 24.01.2005. The matter of his technical resignation was taken up at the 125th Meeting of the Executive Council & the Council accepted the technical resignation of Shri. S. Ghosh w.e.f. 24.01.2005 vide Resolution No.EC:125:2006:6:2:(viii). The decision of the council was accordingly conveyed to Shri. S. Ghosh.

In the meantime, Shri. S. Ghosh vide his letter 27.03.2007 vide (Annexure-B) has stated that inadvertently he had submitted taking resignation w.e.f. 24.01.2005(AN) instead 01.02.2006(AN) (that is the date of his confirmation of service at Institute of Advanced Technology & Management). Hence, he has requested to consider his resignation w.e.f. 01.02.2006 and he has also agreed to pay the Leave Salary & Pension Contribution for the period from 24.01.2005 – 01.02.2006. Council may consider acceptance of resignation w.e.f. 01.02.2006.

The matter is therefore placed before the Council for consideration.

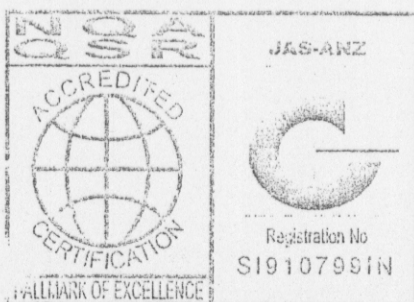
