Similarly, the Executive Council in its 139th meeting held on 11.12.2009 vide resolution No:EC:139:2009:6:1(ii) had nominated the experts in the Selection Committee for the post of Registrar, Finance Officer and Deputy Registrar. The panels are with the then Chairman of the Council.

The interviews for the post of Registrar and Finance Officer already been held. However, the interview for the post of Deputy Registrar, System Analyst, Assistant Editor and Medical Officer could not be held due to technical reasons.
