

- (xiv) Appointment of Head, Department of Mizo, Mizoram Campus, Aizawl.

Dr L. Khiangte was appointed as Reader in the newly opened Deptt. of Mizo, Mizoram Campus on contract basis for a period of two years with effect from 8.2.99. The question of appointing him as Head of the Department vide PVC's letter at annexure - I may not arise since, as per clause 7(3) of the NEHU Statute the period of Headship is for 3 years. Secondly, the Statute is also silent for appointment of Head of Deptt. when there is only one Reader.

Dr L. Khiangte may, however, be considered for appointment as Teacher in-charge in the Deptt. of Mizo till a regular Head of the Deptt. is appointed. For the information of the Council, the Teacher in-charge for the Deptt. of Commerce/CLCS was made on the basis of E.C's resolution No.EC:95:97:6:2(ix) and No.EC:95:97;6:2(viii) dated 15.12.97 at annexure - II & III.

The matter is, therefore, placed before the Council for consideration.

Sir,

I would like to inform you that the Post Graduate Department of Mizo has been functioning in Mizoram Campus for the last two years. The Department has been running the M.A. Course in Mizo Language, the expenditure for which has been met from the grant received from the Govt. of Mizoram. The UGC has agreed to sanction faculty positions for the Department during the Ninth Plan period. But no post has been filled. At the moment, there is one Reader who was appointed on contract basis for a period of two years and he is assisted in teaching by a number of guest lecturers. The Reader has been requested to be in charge of the Department but no official appointment of the Head of the Department has been issued. For the smooth running of the Department, it may be necessary to appoint a regular Head of the Department and I suggest that Dr Lalthantluanga-liana Khiangte, as Reader in the Department, may be appointed as Head of the Department.
