

(ix) Permanent absorption under Nagaland University in respect of Dr.R.P.Kachhara Reader in Geology, Mizoram Campus.

The Executive Council vide resolution NO:EC:93:97:3:(v) held on 15.7.97 approved the grant of one year lien to Dr.R.P.Kachhara, Reader in Geology, Mizoram Campus w.e.f 17.5.96 to 16.5.97 and was extended further for one year w.e.f 17.5.97 to which has expired on 16.5.98.

Before the expiry of the lien, the Dy.Registrar Nagaland University, vide his letter dated 27.3.98 at Annexure-I informed that the Officer decided to continue his service at Nagaland University in which he expressed his willingness to transfer his service from NEHU to Nagaland University vide Annexure - II. Further, the Nagaland University is also willing to absorb his service and has requested for comments from NEHU.
