- (vi) Appointment of part-time teachers on contract basis in the Deptt. of Rural Development and Agricultural Production, Tura Campus, Tura.

The Department of Rural Development and Agricultural Production started functioning at Tura Campus, Tura with the scanty faculty members, who were repatriated from erstwhile Nagaland Campus. As a result the said Deptt. has been facing acute problems in teaching various courses in the multi disciplinary Deptt. of R.D.A.P.

In the 10th plan the U.G.C. has sanctioned a post of Professor only for the aforesaid Deptt. and the same has been advertised in the recent past. As a fallout of this, the Deptt. of R.D.A.P. requested the University to appoint part-time teachers (on contract) against half-time salary basis.

It may be mentioned herein that consequent upon the implementation of Vth pay Commission, the UGC through its notifications in the year 1998 provided the pay scales/qualification for the appointment of teachers in the Universities and Colleges etc. In the notification it also provided for a appointment of part-time teachers, only, in exceptional circumstances when it is appropriate to the requirement of the institution in terms of subject to be taught of work load. However, such part-time teachers will be entitled to half/proportionate amount of the basic of the scale, and other allowances as admissible. Keeping this provisional in view, and due to acute shortage of teachers, the Vice-Chancellor on the recommendation of the Local Selection Committee has appointed the following teachers for the period as mention below:

1. Ms. Joyashree Mahanta, from the date of joining till the end of Semester ending December, 2004.
2. Shri. B.K. Mishra, from 19.2.04 - 20.12.04.

Dr. A.K. Mishra, joined the Department of Linguistics, NEHU, as Reader on 30.5.2002. and was placed under probation for a period of 1 (one) year. He has completed the period of probation on 29.5.2003 and hence due for confirmation on 30.5.2002. i.e. from the date of joining.

The self appraisal report, which is duly countersigned by the H.O.D. in the verification data of Part-II of the form and submitted by Dr. A.K. Mishra will be tabled by the Chair.

The matter is placed before the Council for consideration of confirmation of service of Dr. A.K. Mishra, as Reader, in the University w.e.f. 30.5.2002.

(~~ccii~~) Appointment of Dr.(Mrs) Manorama Sharma as Professor under CAS- effective date of joining.

On the recommendation of Selection Committee vis-à-vis in pursuance of the E.C's Resolution No.EC:112::6:1(i) dt. 27.3.2002, Dr. Manorama Sharma was appointed as Professor in the Department of History under Career Advancement Scheme, w.e.f. date of joining, in the Scale of pay of Rs.16,400-450-20900-500-22,400/- .Accordingly, Dr. Manorama Sharma assumed the charges of the post of Professor of History w.e.f. 11.4.2002.

Normally, a teacher promoted under CAS is allowed the benefit from the due date of eligibility for such promotion and not from the date of joining. But in the instant case the Executive Council decided to allow her the benefit from the date of joining. In view of this anomaly, Professor (Mrs) M. Sharma has represented to the University to look into the matter and set things right accordingly. The representation dt. 25th November 2003 received from the incumbent is placed below at Annexure -A .

It may be mentioned herein that Dr. M. Sharma was appointed as Reader in this University w.e.f. 18.8.1993, and has completed 8 years of regular service in the same cadre on 17.8.2001, and thus became eligible for Professorship under CAS w.e.f. 18.8.2001. Whereas in terms of 112th E.C.'s said resolution the effective date of Dr. Manorama's placement to the post of Professor under CAS to be reckoned from the date of joining and thus there seems to be an anomaly in the effective date of placement. Further, it may not be out of place to mention that along with Prof. M. Sharma, there were also other teachers viz., Dr. D.K. Nayak, Dr. B.S. Mipun (Geography), Dr. B. Myrboh (Chemistry), Dr.(Mrs) M. Momin (History), were considered for placement to the post of Professor under CAS with effect from the date of joining, as per the decision of the Council.

The matter is, therefore, placed before the Council for consideration and decision.
