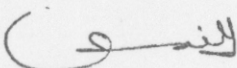
The draft Annual Report for the year 2009-2010 is now ready.

Copy of Article 28 of the NEHU Act:

"Annual Report 28. (1) The annual report of the University shall be prepared under the direction of the Executive Council and shall be submitted to the Court on or after such date as may be prescribed by the Statutes and the Court shall consider the report in its annual meeting. (2) The Court shall submit the annual report to the Visitor along with its comments, if any."
