

(ii) APPOINTMENT OF HEADSHIP FOR USIC

Prof. A.L. Verma, Head of the Department, USIC, NEHU submitted a letter dated 27.9.1999 (ANNEXURE-I), stating that he is not able to devote sufficient time to organise and utilise the facilities in USIC, he has decided to give up the responsibility as Head, USIC and requested to relieve him at the earliest possible and requested to hand-over the charge.

The appointment of Prof. A.L. Verma as Head of the Department, USIC was a stop gap arrangement consequent upon the expiry of the term of re-employed of Prof. T.S.B. Narasaraju on 24.8.1998. The appointment was for a specific period w.e.f. 25.8.1998 to 30.9.1998 or until further orders whichever is earlier. As per the notification, the period of Headship, USIC expired on 30.9.1998 and Prof. A.L. Verma continued to look after the USIC beyond the above date. Since he has expressed his desire to be relieved from the responsibility and in view of the urgent need to Head the Department of USIC, the Vice-Chancellor has appointed Dr. Y.S. Jain to look after the USIC with immediate effect as an interim measure and on a purely temporary charge.

The matter is reported to the Council for ratification.

Sir,

I would like to bring it to your kind notice ~~xxx~~ that I was requested by the Vice-Chancellor to look after the Department of USIC consequent upon the expiry of term of Prof. T.S.B. Narasaraju on 24.8.1998. Although I was not at all willing to take this responsibility as it requires full time attention, I very reluctantly agreed to help the University for only few weeks as is evident from the notification No. F.17-16/Re-Employment/98-322 dated 24.8.1998. Subsequently, I was again requested by the then VC to help the University for some more time with a promise that the University shall try to make alternate arrangements soon.
