Sir,

I beg to inform you that I have been Head for a very long time, (since Aug. 1996 in Shillong, and 1989- June 1996 in Nagaland campus of NEHU) except for a brief period when Dr R. Sachdeva was the Head (Dec. 2002- May 2003), and when Dr A.K. Mishra was Head (Oct. 2003- Dec. 2005). It is only right that someone else should take over. Also, I want to concentrate on the UPE project since this is a major project requiring time and energy. I want to be fully involved in this project as a project investigator since it is an important research work. Because of administrative and other work in this new, under-staffed department I have not been able to do much research work. Now the department is fairly stable and we will be five faculty members when S.A Lyngdoh returns from Study Leave. Lastly, you may recall that I am a cancer survivor by the grace of God, but nonetheless after all the aggressive chemotherapy I had undergone, my energy level has really gone down.

I request you therefore Sir to kindly relieve me from Headship from the next academic year (Feb 2008) since Dr S.K. Singh, Reader would have been confirmed by then (his probation period ends in Jan 2008). I will extend all possible help to him and other colleagues to continue building up and establishing the Department of Linguistics.

I hope that my request will be kindly considered by you and by the E.C.
