

- (vii) Grant of Sabbatical Leave for a period of 1 year w.e.f. 1.8.99 to 31.7.2000 in respect of Prof. R.P. Sharma, department of English.

Prof. R.P. Sharma, department of English has submitted an application dated 14.6.99 (Annexure-I) for the grant of sabbatical leave for 1 year with effect from 1.8.99 to 31.7.2000 to enable him to complete the pending Manuscripts on critique of the politics of nationalism in India and short biography of an eminent educationist of his region. The request for the said leave was forwarded and recommended by the Head of the Department and Dean, School of Humanities and Education.

Prof. Sharma joined this University on 21.3.79 as Lecturer and was promoted to Reader under M.P.S. with effect from 18.8.84.

Dr. R.P. had initially availed E.O.L. for 2 years with effect from 1.10.89 to 30.9.91 vice E.C. resolution No. EC:67:89:03:(vi) for taking up the assignments in the University of Sonas Yemen Arab Republic. Subsequently, Dr. Sharma applied for extension of E.O.L. for another one year which was granted by the E.C. resolution No. EC:72:91:6:03:(vii) with effect from 1.10.91 to 30.9.92 but Dr. Sharma reported back for duties on 13.7.92 before expiry of the E.O.L. period on 30.9.92. He has thus, served the University more or less 7 years after expiry of the leave availed.

Having examined the case, Prof. Sharma fulfils the conditions laid down in the University Ordinance subject to execution of the Bond under Clause 11(iii) of OE-6 of the Ordinance.

In view of the above the matter is placed before the Executive Council for consideration and order.

Dear Sir,

I've been stuck up, for want of time, with two manuscripts for quite sometime now. One of these manuscripts proposes to be a fairly comprehensive (in approximately 1,50,000 words) critique of the politics of nationalism in India, while the other one intends to be a short biography (in approximately 50,000 words) of an eminent educationist of this region. As I've not succeeded in combining my work on these manuscripts with my work in the department, I've decided to devote all my time (by taking my time off the department) to completing these manuscripts within a reasonable period. I hope to be able to complete these manuscripts in a year's time if I work full time on them. I'd therefore like to avail myself of Sabbatical Leave from 01 August 1999 to 31 July 2000 under OE-6-11.

I've never before availed myself of sabbatical leave in more than twenty years of my permanent service here. Besides, I've more than six years to reach the age of superannuation.

I may assure you that I should be able to place before you (on the expiry of the leave) concrete evidence of how I would utilize the period of sabbatical leave.

I would also like to point out here that for most of the time during my leave, I'd be in Shillong.

I should be grateful if you could kindly grant me sabbatical leave for one year from 01 August 1999 to 31 July 2000.
