

(x) Appointment of Teachers to Honorary Positions

In pursuance of Resolution No. EC:96:98:6:2(xi) adopted at the 96th meeting of the Executive Council, a Committee was constituted to look into the matter regarding the appointment of teachers to Honorary positions. In this connection, the report of the said Committee is placed at Annexure - 'A' for perusal. It may be noted that the Executive Council's decision as referred to above pertained only to teachers appointment to Honorary positions and not to any other category. But the aforesaid Executive Council's Committee in its report, under reference, appears to have extended its term of reference even to categories other than Honorary positions.

The matter is placed before the Council for consideration.

MINUTES OF THE EC SUB COMMITTEE

As per notification No,EC:96-4/Conf/98-649 dated 2-4-98, a committee was constituted to look into the matter regarding the appointment of teachers to honorary positions. The Committee met on 1st July, 1998, deliberated on the issue and decided as follows :

(1) The members feel that if one has to do justice and devote sufficient time to discharge the responsibility of the office held, same person should not be given two or more positions/ responsibilities out of the following categories:

- (i) Head of the Department/Centre.
- (ii) Dean of a School.
- (iii) Registrar.
- (iv) Finance Officer.
- (v) Controller of Examination .
- (vi) Librarian.
- (vii) Chief Proctor.
- (viii) Proctors.
- (ix) Dean of Students Welfare.
- (x) Director of Sports.
- (xi) Director, College Development Council.
- (xii) Director/In-Charge, NSS.
- (xiii) Director/Head, RSIC.
- (xiv) Director/Head, USIC.
- (xv) Director, Computer Centre.
- (xvi) In-Charge, Campus Development Department.
- (xvii) Head/Director, State Resource Centre.
- (xviii) Director/Head, Research Centre in Bio-Sciences.
- (xix) Head, Distance Education.
- (xx) Head/Director of any other Centre/Department.
- (xxi) Pro-Vice-Chancellor.

(2) However in exceptional and emergent situation, one may be given additional responsibility of up to two positions for not exceeding sixty days. During this period, suitable arrangement should be made as per suggestions under item(1) above, if required.

(x) Appointment of teachers to Honorary position.

EC:104:99:6:2: (x): The Council considered the recommendations of the Committee to look into the appointment of teachers to Honorary positions and RESOLVED that the recommendations of the Committee may be accepted only in respect of posts of a purely honorary status.

(xi) Joint representation for reconsideration of reemployment for one more year.

EC:104:99:6:2: (xi): The Council considered the joint representation for reconsideration of reemployment for one more year and RESOLVED that marginal cases, i.e., those who retired within 6 months before the notification of 27th July, 1998 may be considered for extension or reemployment up to a period of one year. Contractual appointment may be made for non-marginal cases till the end of the current semester.

(xii) Confirmation of service in respect of Dr. KM Rao, Lecturer, NEHU, Shillong.

EC:104:99:6:2: (xii): The Council considered the confirmation of service of Dr. KM Rao, Lecturer in Chemistry and RESOLVED to approve the same w.e.f. 16.9.97.

(xiii) Further extension of the contract term of appointment of Shri SR Sen as University Legal Adviser (Hd.Qtr.), Shillong for a period of 3 years with effect from 28.7.99.
