(v) Amendment of Clause 4(1) of Ordinance  
OC-4- Ph.D. Registration.

The School Board of Economics, Management and Information Sciences in its meeting held on 28.10.98 considered and approved the proposed changes/Amendment of Clause 4(1) of Ordinance OC-4 as recommended/ approved by the Board of Post Graduate Studies (Economics). The proposed changes in Clause 4(1) of OC-4 may be approved by introducing a proviso as Under :

"Provided that the application for registration for Ph.D be made within 1 (one) year of admission by the Department. If the candidate failing to apply for registration within the said period, he/she would be deemed to have dropped the Ph.D Programme and thus his/her admission stands automatically nullified without any action taken or notice served by the Department. The candidate may, however, seek a fresh admission to Ph.D Programme if he/she so desires".

The existing provision for Ph.D. Registration in term of Clause 4(1) of Ordinance OC-4 reads as under:-

"(1) The application for registration for Ph.D. shall be made to the Department concerned in the proforma as may be prescribed by the University along with a detailed research proposal including the topic, scope of its study, tentative hypothesis, research methodology including sampling and design, where necessary. The Department shall forward the research proposal to the School through the Board of Post Graduate Studies. The date on which the School Board accepts the proposals for registration shall be the date of registration of the Scholar for the purposes of this Ordinance."

The matter is placed before the Council for consideration.

- (vi) Report of the Committee appointed by the Executive Council to examine the jurisdiction of the EC/AC Vis-a-Vis Academic Matters.

In the 98th meeting of the Executive Council vide Resolution No. EC:98:98:5:1(iv), the Council considered the recommendation of the Committee appointed by it to examine the jurisdiction of the EC/AC Vis-a-Vis Academic Matters and resolved to approve the same in principle and the matter ~~to~~ referred back to the Academic Council with proposed amendment of Clause 4(c) of Ordinance OA-7 as per Annexure 'A'.

MINUTES OF THE COMMITTEE APPOINTED BY THE  
EXECUTIVE COUNCIL VIDE RESOLUTION NO.EC:97:98:8:(i) TO  
EXAMINE THE JURISDICTION OF THE EXECUTIVE COUNCIL/  
ACADEMIC COUNCIL VIS-A-VIS THE ACADEMIC MATTERS.

The Committee went through the powers and functions of the Executive Council and the Academic Council as laid down under Section 20 and 21 of the NEHU Act, 1973 and also Statute 13 and 15 of the first schedule of the Act, As per the Act and the Statutes the Academic Council is the 'principal body' with regard to academic matters, while the Executive Council is the 'principal executive body' of the University. The Committee after a thorough deliberation decided that though no powers have been given to the Executive Council with regard to academic matters but since the Executive Council is the "Principal Executive Body" of the University, structural/policy matters such as creation/establishment/closure of new departments/centres/courses (U.G. and P.G.), modification in the course structure, criteria/quota for admission of students, structure of examinations etc., should perhaps be placed before the Executive Council as it is the principal executive body of the University. In any case such matters shall have to be placed before the Executive Council as these involve amendment of the Ordinances/Regulations.

During the course of discussion it was observed that while the Syllabi for the Under-Graduate Courses have to be approved by the Academic Council as per Clause 5(e) of Ordinance OA-9 and the Post-Graduate Courses are approved by the School Board under Clause 4(c) of Ordinance OA-7. This is perhaps anomalous as Statute 15(a) of the NEHU Act, the Academic Council has the power to supervise the academic policies and also maintain the academic standard of the University. It is therefore felt that Clause 4(c) of Ordinance OA-7 may be suitably amended so that the Post Graduate Courses are also approved by the Academic Council on the recommendations of the School Board.

- (vii) Regulation of Admission and fees structure in Private Non-Aided Professional Institutions.

The University Grants Commission has recently framed certain Rules and Regulation(at Annexure-A) to streamline the Admission into and fees payable by the students of private non-aided professional Institutions and the same has been enacted and published in the Gazette of India on May, 16,1998.

The Act, provides that the University should follow the provisions laid down in the Act in letter and spirit by constituting Committees to consider for fixation of fees payable by the students seeking admission into such institutions.

The matter is placed before the Council for consideration.

UNIVERSITY GRANTS COMMISSION

Annexure 'A'

Bahadurshah Zafar Marg  
New Delhi, the October, 1997

No.F 4-22 93:CPP-2): Whereas the University Grants Commission satisfied that it is necessary to regulate admission and levy of fees in private unaided professional educational institutions: self-financing deemed universities and Joint venture universities in public interest:

Now, therefore, in exercise of powers conferred by clause (1) of sub-section (1) of Section 26, read with sub-section(2) of section 12-A, of the University Grants Commission, with the previous approval of the Central Government and after consultation with the Universities concerned hereby makes the following regulations, namely:-

1. Short title and commencement:-

- (1) These regulations may be called the University Grants Commission (Regulation of Admission and fees in Private Non-aided Professional Institutions) Regulations, 1997
- (2) They shall come into force on the date of their publication in the Official Gazette.

2. Applicability:-

These regulations shall apply to:

- (a) colleges affiliated to the Universities and operating on 'no grant-in-aid' basis:
- (b) institutions deemed to be universities under section 3 of the Act, if such institutions operate on self-financing basis without receiving maintenance grants from the Central Government, any state Government or any statutory body under their control and disbursing grants:
- (c) Universities not receiving grant-in-aid from the Central Government or any State Government or any grant disbursing statutory bodies of such Governments for the maintenance or development expenditure of such universities: and
- (d) Universities established as a Joint venture between a private trust or society and a State Government.

3. Designations:-

In those regulations, unless the context otherwise require:-

- (a) "Act" means the University Grants Commission Act, 1956(3 of 1956);
- (b) "appropriate authority" means the Central Government, a State, the commission, a University or other authority which under any law for the time being in force, is competent to grant permission to establish or to grant recognition to, a professional educational institution;
- (c) "Commission" means the University Grants Commission established under section 4;
- (d) "Committee" means the Standing Committee of the Commission or the State Level Committee, as the case may be;
- (e) "Competent authority" means the University Grants Commission

the Central Government a State Government or a University or any other authority, as may be designated by the Commission to determine the fees of scales of fees payable by students and the allotment of students for admission to various professional institutions:

- (f) "fees" in relation to payment seats or free seats means all the institutional fees including tuition fee and development fee;
- (g) "Free Seats" means the seats on which the fee payable by a student seeking admission to, and prosecution of, a course of study at a level corresponding to the fees as specified for the Government colleges and institutions in the concerned State or Union territory in respect of similar courses of study;
- (h) "institution" means a college affiliated to a University or approved or recognised by Government or any competent statutory body, including the All India Council for Technical Education, Dental Council of India, Medical Council of India and National Council for Teacher Education established or incorporated by, or under, a Central Act or a State Act, and includes an institution deemed to be a University declared by the Central Government on the recommendation of the Commission under Section 3 and all institutions recognised by the Commission under clause (f) section 2 and imparting education;
- (i) "NRI" means a Non-Resident Indian and the Expression "non-resident" has the same meaning as assigned to it under the income-tax Act, 1961 (43 of 1961);
- (j) "professional institution" includes any private unaided institution imparting education in Social Work Home Science, Library Science, Education, Computer Science, Commerce, Law and the like and includes such other institution to which these regulations are made applicable by the Commission;
- (k) "Payment Seats" means seats other than Free Seats and for which fee payable by a student seeking admission to, and prosecution of, a course of study shall not exceed the limits specified under these regulations:
  - (1) "section" means a section of the Act; and
  - (m) "Student" includes a person seeking admission in a course of study.

#### 4. Admission:-

- (1) No student other than a student who fulfils the requirements of the University Grants Commission (the minimum standards of institutions for the grant of first degree through form education in the faculties of Arts, Humanities, Fine Arts, Music, Social Sciences, Commerce and Sciences) Regulations, 1985, shall be eligible for admission to a first degree course or to a post-graduate level professional course of study.
- (2) Without the previous permission of the appropriate authority no institution shall start a new or higher professional course of study.
- (3) The competent authority shall call for applications for admission to the seats available in any academic year in the institution.
- (4) The competent authority shall advertise in at least three leading newspapers out of which one shall be in a local vernacular language, the number of seats available for admission institution-wise, the fees to be charged for the duration of the course, separately for both Free seats and payment seats, and the procedure and schedule for admission.

5.(5) At the time of inviting applications for admission in any course of study the competent authority shall fix a last date for the allotment of Free seats.

(6) The competent authority shall issue a brochure containing the application form for admission full particulars of the course, number of seats available, names of the professional institutions and their location, the fees chargeable by each professional institution, the minimum eligibility conditions for admission and such other particulars as may be deemed necessary by the competent authority.

(7) The application form for admission issued by the competent authority shall contain a column wherein an applicant shall indicate the order of preferences, whether he wished to be admitted against a Free Seat or a Payment Seat, or both as well as the preference of institutions, in case of more than one institution is offering the same course.

(8) In case the admission to a course of study is given on the basis of results of a common entrance examination, the competent authority shall prepare a merit list of candidates from amongst the successful candidates based on their merit position.

(9) Where the admission to a course of study is not based on a common entrance examination, admission shall be given to the course of study on the basis of such other criteria as may be determined by the competent authority:

Provided that no such criterion as has not been notified by the competent authority shall be applied by him.

(10) The result of the entrance examination, if any, held shall be published in at least three leading newspapers, one of which shall be in local vernacular language and shall also be displayed on the notice boards of the concerned institution(s)

(11) (i) At least 50 per cent of the seats in every professional institution shall be Free Seats and the remaining 50 per cent by payment seats.

(ii) The criteria of eligibility and other conditions shall be the same in respect of both Free Seats and payment Seats except that the higher fee is to be paid for payment Seats.

(iii) The management of a professional institution shall not be entitled to impose any additional eligibility criteria or conditions for admission either to Free Seats or Payment Seats.

(Contd---)

(12) After the Free Seats are filled within the specified time, a further date shall be fixed by the competent authority giving time to the candidates who opt to be admitted against the payment Seats.

(13) (i) The competent authority shall also prepare and publish a waiting list of candidates alongwith the marks obtained by them in the entrance examination.

(ii) After the allotment of the last seat is made, the waiting list shall be operated for filling any casual vacancies or drop-out vacancies. These vacancies, shall be filled until such date, as may be notified by the competent authority.

(iii) The competent authority shall decide a cut-off date beyond which no one shall be admitted so as to ensure that a student does not miss a good part of the syllabus of the semester of term.

#### 5. Constitution of Committees for fixation of fees payable:

(1) The fees for;

- (a) professional institutions affiliated to Central Universities;
- (b) any professional institutions which are deemed to be Universities
- (c) Universities not receiving grant-in-aid from the Central Government or any grant disbursing statutory bodies of such Governments for the maintenance or development expenditure of such Universities; and

(d) Universities established as a joint venture between a private trust or society and a State Government.

(2) The Standing Committee referred to in sub-regulation

(1) Shall consist of;

(a) A Member of the Commission Chari person;

(b) (i) One Vice-Chancellor to be nominated by the Commission-Member;

(ii) Three experts, one each in Economics, Cost Accountancy and Institutional Finance, to be nominated by the Commission-Members;

(iii) One Expert in the subject area-Member.

(iv) In case a deemed University conducts courses of study such as technical education, medical education and teacher education of which there is a statutory council, for example, the All India Council of Technical Education Medical Council of India Dental Council of India and the National Council for Teacher Education, a nominee of such Council-Member;

(v) Secretary in charge of Higher, Technical or Medical education (depending on the field of specialization of the institution) of the concerned state Government or his nominee who is not below the rank of Deputy Secretary to the Government of India may be co-opted as a member for the purposes only of determining the fee structure for deemed universities in the State concerned;

(vi) An officer of the Commission not below the rank of Additional Secretary-Member, Secretary.

3. (I) The fees in professional institutions affiliated to State Government Universities shall be determined by a Committee called the State Level Committee:

(ii) The state level Committee which may be constituted in every state by the Commission shall conduct of:

- (a) Vice-Chancellor of one of the Universities in the State nominated by the State Government concerned-Chairperson;
- (b) Secretary incharge of Higher Education of the State Government concerned-Member;
- (c) Secretary of the Finance Departments of the State Government concerned-Member;
- (d) Three experts, one each in Institutional Finance Cost Accountancy and Economics to be nominated by the Commission-Member;
- (e) A Finance Officer of one of the Universities to be nominated by the State Government-Member; and
- (f) Director in charge of Higher or Collegiate Education of the State Government concerned Member-Secretary.

6. Procedure to be adopted by the Committees;

- (1) Secretarial assistance to the Standing Committee of the Commission shall be given by the Secretariat of the Commission.
- (2) Secretarial assistance to the State Level Committee shall be given by the Directorate of Higher Education of the State Government concerned.
- (3) The term of office of the Members of the Standing Committee constituted under sub-rule (1) and the State Level Committee constituted under sub-rule (2) of rule 5, other than the ex-officio Members shall be three years.
- (4) The Standing Committee and the State Level Committee shall review the fee structure at an interval of three academic years.
- (5) (i) Subject to provisions of these regulations, the Committees are free to advice their own procedure. The procedure shall, however, compulsorily include giving opportunity to the institutions concerned to furnish such material as they may consider relevant.  
 (ii) The Committees shall also have power to call for such information and details as they may consider relevant for fixation of fees.  
 (iii) For the purpose of carrying out its functions effectively the Committees shall lay down a time bound 'action-calendar' and 'dead-lines' for compliance by the institutions concerned and for completing tasks of the Committees.
- (6) The Committees may determine different rates or scales of fees for different classes of institutions, if a classification is justified on intelligible and objective criteria. In particular the Committees shall be free to fix different rates for institutions located in rural areas and urban areas.

- (7) The Commission may at any time call for information and clarification from the Committees and the Committees shall be bound to furnish such information or clarification.
- (8) While determining the fee chargeable, it shall be the duty of the committees to ensure that the fee does not become a source of profit or commercialisation for the institutions concerned.

6. Procedure for determining fees:-

- (1) (i) Fees of the scales of fees once prescribed under these regulations shall be valid for a period of three years.
- (ii) The fees when revised shall be applicable only to new entrants.
- (2) (i) A professional institution shall submit to the Commission at least six months before the advertisement for admission, authentic data on the basis of which the tuition and other fees are to be determined.
- (ii) The concerned Committee may seek any data or clarification from the concerned professional institutions and may also allow the institution to supplement or modify the data submitted by it originally.
- (iii) While deciding the fee structure for Free Seats, Payment Seats and NRI Foreign students, the concerned Committee shall take into consideration, the parameters which affect the cost, the total expenditure of the institution for running the professional course as computed on the basis of audited statements of the previous two years and reasonable projected estimation for the next three years.
- (iv) The fees to be charged shall have two broad categories, namely, tuition fee and development fee.
- (v) The management of the institution may realise the actual cost of board and lodging from the students subject to the relevant committee being satisfied about the reasonableness of such costs.
- (vi) The tuition fee shall be to meet the actual cost of imparting education.
- (vii) While assessing a fair tuition fee, the Committee shall take into account the following, namely:
- (a) Salary and allowances including bonus, if admissible, payable to teaching and non-teaching employees;
- (b) expenditure on administrative services;
- (c) cost of maintenance of laboratories including consumables;
- (d) contingent expenditure including statutory requirements like audit fee, and the like;
- (e) cost of acquisition of books and journals for libraries;
- (f) maintenance of buildings and other assets including rents and tariffs; and
- any other recurring expenditure to be determined by the competent authority from time to time.
- (viii) Having due regard to the parameters mentioned in this sub-regulation, suitable rates may be fixed for holder of Free Seats, Payment Seats                      NRI Foreign students.
- (3) (i) The Commission shall specify: norms relating to staffing and scales of expenditure for other items wherever such norms have not been laid down till the date of commencement of these regulations.

(ii) In case the Commission finds it difficult to lay down specific quantified norms, the relevant Committee shall satisfy themselves about adequacy and the reasonableness of the expenditure invol.

(iii) While specifying the norms the Commission shall ensure that the projected expenditure does not become a source of profit to the management of the professional institutions.

#### 7. Note.

As the scheme laid down by the Supreme Court of India in Unnikrishnan J.P. Versus State of Andhra Pradesh (A.I.R. 1993 S.C.2178) prohibits Commercialization of education and profit making, it shall not be open to the institutions concerned to claim any return on investments. This may however, not come in the way of the institutions immobilizing resources for the replacement and upgradation of assets. Further, while earning returns on the investment would not be permissible as per the judgement and order of the Supreme Court of India in Unnikrishnan J.P. Versus state of Andhra Pradesh (A.I.R, 1993 SC 2178) the court had, left the question of recovering investment on the Central Government and the Statutory bodies. It is therefore, considered desirable that the development fee could provide for an element of partial capital cost recovery to the Management (but not a return on investment) and to serve as a recourse for upkeep and replacement.

(4) (i) The Commission shall at an interval of three years determine the development fee and different rates of development fee and different rates of development fee may be specified for students of Free Seats, Payment Seats and Foreign NRI seats.

(ii) The development fee may be at flat rates.

(iii) Based on intelligible and objective criteria the Commission may classify the institutions into different categories for the purpose of prescribing different slabs or rates of development fees.

(iv) While determining the rates of development fees, the Commission shall take into account the views and suggestions of the private professional institutions, the State Government and interested members of the general public.

(5) No management of a professional institution shall, in the first ten years of its establishment, appropriate more than fifty per cent of the proceeds of the development fee levied or the actual capital cost, whichever is lower, for the recovery of the capital cost. The remaining amount shall be utilized for upgradation and replacements in the said first ten years and, therefore, the entire proceeds may be utilized for upgradation and replacement purposes.

## Part III. Sec.4

- (6) The Commission shall communicate the approved rates of development fee chargeable by the professional institutions to the Committees well in advance so as to enable them to suitably incorporate such rates in their notification.

## 7. Admission of students.

- (1) Admission in institutions under the management of minority shall be regulated as under:-

(a) 50 percent of the seats in professional institutions established and administered by a minority shall be filled on the basis of merit list prepared by the competent authority. Out of these 50 per cent seats, half shall be Free Seats and the other half shall be Payment Seats.

(b) The remaining 50 percent of seats shall be filled by the management of the institution from amongst the candidates belonging to the concerned minority community out of which half shall be Free Seats and other half shall be Payment Seats.

Explanation - For the purposes of this clause, Payment Seats shall include seats for Foreign, NRI students.

(c) After completing the admission, each minority professional institution shall submit to the competent authority, the concerned University and the concerned State Government, a statement containing full particulars of the students admitted against 50 per cent seats filled up by the management from amongst the candidates belonging to the concerned minority.

(2) Private Professional institutions shall be permitted to admit the NRI foreign students upto a maximum of 5 per cent of the total sanctioned intake capacity to be determined from time to time by the competent authority for each academic year. This percentage shall be out of Payment Seats. The NRI Foreign students shall be admitted on the basis of merit. But, in view of the difference in their backgrounds the competent authority of the professional institution concerned may judge the merit of these candidates, having regard to all the relevant factors.

(3) (i) There shall be no quota of seats for the management or for any family, caste or community which had established the professional institution.

(ii) The competent authority may, at its discretion, fill any seat which may remain unfilled in five per cent. NRI quota in any academic year.

(iii) The fees chargeable from the students admitted under this sub-regulation shall be the same as chargeable for the students admitted against Payment Seats and not against the NRI seats.

## Part III.Sec.4

- (4) It shall be open to the private professional institutions to provide for reservation in seats for constitutionally permissible classes of candidates such as the scheduled castes, the scheduled tribes, other backward classes and others under intimation to the affiliating Universities. Such reservations, if any made, shall be notified to the competent authority and the appropriate authority at least one month per year to the issuance of the notification calling for applications for admission to such category of professional institutions. In such cases, the competent authority shall not allot students, keeping in view the reservations provide by a professional institutions. The rules of merit shall be followed even in such reserved categories.

## 8. Intepretation.

- (1) If any question arises as to the interpretation of these regulations, shall be decided by the Commission.
- (2) The Commission shall have the power to issue clarifications to remove any doubt which may arise in regard to the implementation of these regulations.

## 9. Maintenance of account of fees -

- (1) Every institution shall maintain two separate accounts, namely, the Maintenance Accounts and the Development Accounts.

- (2) (i) The proceeds of tution fee and cost recoveries of board and lodging charges and other miscellaneous fees shall be credited to the maintenance accounts.

(ii) The maintenance accounts shall be kept in two parts, namely, (a) the pay and allowance, and (b) the other expenditure.

(iii) All recurring expenditure shall be met from the maintenance account and brought to account in the part relating to pay and allowances, or as the case may be, under the other expenditure.

(c) At least half of the proceeds of development fee shall be credited to the development account in the first ten years of establishment of the institution, after which this account (Development Account) will receive the entire proceeds of this fee Miscellaneous receipts of the institution would also be credited to the same accoung. The proceeds of this fee would be utilized for the procurment of equipment, books and journals and the acquisition of assets. The management may debit expenditure on improvement of faculty to this account.

(d) The accounts of the professional institutions shall be audited every year to ensure that the financial management conforms to the broad framework of these regulations and the guidelines issued by the commission from time to time.

10. Other procedural matters connected with levy of fees.

(1) (i) Fees once fixed shall be valid for a period of three years.

(ii) Fee may be payable in advance for a semester.

(iii) Each Committee shall notify in the month of December every year, for general information, the total fee payable per semester for the next year, in three newspapers having circulation in the State concerned. Every year, the committee shall fix the fees applicable for the third year.

(2) While fixing the fees every year, the committee shall take into account the unspent balance, if any, in the maintenance and development accounts of the concerned professional institutions.

(3) No professional institution shall:

(i) levy any fee exceeding the fee notified under these regulations.

(ii) Fail to maintain accounts required to be maintained as per the provisions of these regulations or the guidelines issued by the Commission.

- (iii) Condonation of break and extension of time in the M.Phil Programme in respect of Mr Imkongwapang, Department of Zoology.

The case of Shri Imkongwapang, Department of Zoology for condonation of break and extension of time in the M.Phil Programme was discussed in the meeting of the Board of Research Studies which was held on the 15th November, 1997. The Board has referred back the matter to the School Board of Life Sciences for further examination. On the recommendation of the Board in its meeting held on 18.12.97 the matter was again discussed in the last meeting of the Board of Research Studies which held on 13rd November, 1998 and the resolution in this respect is reproduced below :

" The Board considered the extension case of Mr Imkongwapang, Department of Zoology and RESOLVED <sup>and authorized the Chairman</sup> to condone the break under clause 14 of Ordinance OC-5, as a very special case, not to be quoted as a precedent in future"

5:5:4(i)

Proposed Re-evaluation Principle vis-à-vis the Part I and Part II system of Examinations.

Under the annual system of examination a candidate could automatically move on to the next higher class without having to wait for the results of the examination written. Under this system, the results of the re-evaluation were required to be known only before such candidates could fill in their next examination forms, which was normally in Nov./Dec. Such being the system, the then re-evaluation principle was made liberal and open, since there was no risk, on this count, to the non-fulfilment of the minimum requirement of 180 teaching days.

However, since under the Part I and Part II examinations, a candidate is required to clear Part I examinations, before being admitted to the Part II course, the application of the same principle of re-evaluation is bound to create some legal complications, as it is not possible to bring out the re-evaluated results so fast for the University as to be able to ensure fulfilment of the minimal requirement of 180 teaching days. (It may be noted that a period of one month, from the date of publication of the concerned results, is required to be given for filling in of such forms).

In the face of such problems, the following modifications on re-evaluation are being proposed to the Academic Council for consideration and decision:

- 1) For the Part I Examinations, there may only be **SCRUTINY** and the University may do away with the provision of re-evaluation.
- 2) For the Part II Examinations, we may continue to have re-evaluation on the existing principle, with the limitation of only one re-examiner. The original marks and the marks of the re-examiner could be averaged for determination of the marks of re-evaluation.
- 3) Other conditions of re-evaluation at Annexure "A" may continue to be operative.

The above modifications are proposed only with the view to avoid legal complications as also to ensure expeditious disposal of such cases in the light of the newly changed system of examinations.

The above proposals are therefore submitted to the Academic Council for consideration and approval.

## RE-EVALUATION RULES

1. A candidate may within 30 days of declaration of results apply for re-evaluation of not more than two papers paying a fee of Rs. 150/- (one hundred fifty) only per paper.
2. Provided further that no such request be entertained for practical papers:
3. All requests for re-evaluation shall be accompanied by:
  - i) A Demand Draft in favour of Controller of Examinations, NEHU or Nehu Challan for the amount prescribed above.
  - ii) The original mark-sheet issued by the University.
4. The application shall be screened by the Controller of Examinations and shall be sent to two examiners, other than the ones who have examined the script earlier, appointed by the Vice-Chancellor.
5. Average of the two closer marks awarded by the examiners shall be the marks awarded after re-evaluation.
6. The score after re-evaluation shall supersede the earlier score provided that a candidate who was declared pass initially shall not be declared unsuccessful as a result of re-evaluation and downward revision of marks shall be limited to pass level.
7. No retrospective benefit such as award of Gold Medal, Scholarship, Fellowship admission, promotion, etc., shall accrue to a candidate as a result of re-evaluation.
8. **Re-evaluation shall not be a time-bound process but all effort will be made to ensure early declaration of result.**
9. Candidates who secure more than or equal to 15% and less than or equal to 40%.
10. Candidates who secure less than or equal to 4/5th (80%) of the average percentage of marks obtained in the rest of the papers. To illustrate whereas under the old formula a candidate wishing to go for re-evaluation where he/she has secured 42% was to have secured 70% in the rest of the papers, now under the new formula a candidate with 42% marks in a paper can go for re-evaluation of a paper if she/he secures 56% in the rest of the papers. For ready reference please see the "Ready Reckoner" appended below.
11. A candidate shall be eligible for re-evaluation *only in two papers* in a particular year of examinations (as per existing provisions).
12. In addition to the modified provisions of re-evaluation the rate for **scrutiny** shall be Rs.100/- per paper.
13. If the improvement in the re-evaluation is equal to or less than 5% over the original marks, the difference will be ignored and show as NO IMPROVEMENT over the original and the original marks shall be retained.

WORKING RULES FOR REPETITIONS/IMPROVEMENT/RE-EVALUATION :

Consequent upon the decision of the 50th meeting of the Academic Council held on 2nd and 3rd November, 93, the following working rules may be followed from the forthcoming examinations onwards :

I. REPETITIONS :

Repetitions in the failed subject(s) (those securing less than 30% in a particular paper(s)) will be available to all the new course candidates upto the permissible chances (i.e. 2+2 for the Pre-University and 3+2 for the Degree Courses) as already notified earlier.

II. IMPROVEMENT :

a) Improvement facility will be available to the new course candidates DURING THE CURRENCY of the course in partial modification of what have been notified earlier.

b) This facility will, however, be limited to those candidates securing less than 45% in the concerned paper(s).

c) This facility will also be available ONLY ONCE during the entire currency of the course within the permissible chances, that is, 2+2 for the Pre-University and 3+2 for the Degree courses.

d) The original marks of a candidate shall stand forfeited if he/she decides to go for improvement.

|| III. RE-EVALUATION :

Re-evaluation facility will be available to the following category of candidates :-

a) Candidates who secure more than or equal to 15% and less than or equal to 40%.

b) Candidates who secure less than or equal to 4/5th (80%) of the average percentage of marks obtained in the rest of the papers. To illustrate whereas under the old formula a candidate wishing to go for re-evaluation where he/she has

secured 42% was to have secured 70% in the rest of the papers, now under the new formula a candidate with 42% marks in a paper can go for re-evaluation of a paper if she/he secures 56% in the rest of the papers. For ready reference please see the "Ready Reckoner" appended below.

✓ c) A candidate shall be eligible for re-evaluation only in two papers in a particular year of examinations (as per existing provisions).


✓ d) The re-evaluation fees shall stand revised to Rs.150/- per paper to meet atleast the cost of re-evaluation.

✓ e) In addition to the modified provisions of re-evaluation the existing provision of SCRUTINY shall stand.

Sub: Proposed Fees Structure for Diploma and Certificate Courses.

Sir,

This is inconnection with your query about the proposal for Fees Structure to be made payable by candidates undergoing Diploma or Certificate Courses in this University. This is to inform that the matter has been considered by the Department, which is of the view that the fees structure for such courses could be based on the same analogy of the fees, as being charged, for the MA/M.Sc. Courses since the basis infrastructural and personnel inputs required for the running of such courses would be required also for the running of such Diploma and Certificate Courses. The only difference that could be considered is with regard to the duration of such courses. The Department is, therefore, of the view that the differences in the duration of such courses automatically differentiate themselves from the Master's Degree Course, which are of Two Year's duration, Diploma one year and Certificate courses six months respectively.

The fees structure proposed would, therefore, be as follows:-

The Comprehensive School and Degree College, Venghlui, Mizawl formally known as Mizoram Special Hindi School Mizawl was inspected on 16th October, 1998 at 11.30 AM to verify the infrastructure and other facilities for affiliation of the college to North Eastern Hill University, Shillong. It was observed by the inspection team that the college has adequate infrastructure only for the present i.e. up to first year of graduation. In the coming years when second and third year classes will also be there, college will require more classrooms and bigger laboratories for science subjects. Since the college has already been allotted a big piece of land, it should give first priority to shifting over there. The inspection team recommends provisional affiliation for two years and the college may be inspected again to see that the following conditions are fulfilled during this period.

a) Additional teachers in accordance with NEHU norms are appointed in subjects where college is seeking affiliation for honours classes. The Govt. of Mizoram has already promised eleven teaching posts for the college and these should be used for such appointments only.

b) The college has been sanctioned a sum of Rs.11 lakhs for library and equipment and this sum should be utilized immediately to equip the college library and laboratories in science subjects.

R E C O M M E N D A T I O N S

1. The last inspection team reported that the College did not seek academic affiliation from 1980-81 and the University may ask the College to seek the same.

Presuming that the inspection team was constituted following the request of the College it is recommended that the college be granted affiliation from 1980-81 to 1997-98, to regularise the same.

2. From 1998-99 the college has started the new three year LL.B, course as per the directive of the Bar Council of India. The BCI inspection team inspected the college twice - on 27.8.96 and on 11.4.98. Both these inspection teams directed the College to appoint full time regular teachers as per UGC norms.

The College has not appointed full time regular teachers so far. The classes are being managed so far as before with the help of part time teachers and those appointed on contract basis. Those Teachers as are referred to as full time teachers by the college authority also cannot be termed as regular teachers as per UGC norms, which has also been pointed out by BCI inspection team in its report dated 11.4.98.

3. Therefore we recommended that from 1998-99, the college be affiliated provisionally subject to (i) the appointment of regular teachers as per UGC norms before June '99, (ii) The college should start functioning from 9 A.M. as the LL.B. Course is now intended to be a full time course. Unless this is done the standard will not improve and the Pass percentage will continue to be low (iii) The College Library should also remain open from 9.A.M. to 4 P.M. to enable both the students and the teachers to make full use of the same (iv) The College should also appoint a trained Librarian by June '99.

4. The BCI Inspection team in its report dated 11.4.98 observed thus:

3. "During the course of discussion it was brought to our notice that the college was originally affiliated with the Gauhati University from 1964 to 1975 and thereafter with NEHU. It has been brought to our notice that there is no Law Faculty would not be in a position to set proper question papers to the Law students nor such University can provide proper Syllabus to them. Under these circumstances we the Undersigned further direct the College authorities to withdraw their affiliation from NEHU and should endeavour to seek fresh affiliation either with Gauhati University or with some others University having a law faculty".

On the basis of this recommendation the BCI (Vide letter No. BCI:D:654:1998 (LE/Mtg), dt. 27. July 1998) wrote to the Registrar NEHU, asking him to send his comments including proposed steps to be taken on this by the University. Therefore we take this opportunity to comment on the same as below:

- (i) Papers for LL.B. Examination are set by teachers of law subjects drawn from Law faculties of the law colleges and P.G. Departments of Law of the Universities in the region; hence, they are as proper question papers as elsewhere: (ii) the LL.B. Syllabus likewise is prepared by BUGS in law most members of which are also drawn from Law Colleges and P.G. Departments of Law from the Universities in the region and thus the syllabus is also proper as elsewhere: (iii) the affiliation is granted to a college by the University and only the University can withdraw the affiliation granted to a college; (iv) In future when a college is to be inspected by a team constituted by an outside Agency, the college should request the University to depute its nominee also to be present at the time of inspection. In future no college under the

jurisdiction of the University be inspected without a representative of the University, All College be informed accordingly.

5. There is another item in the report which also deserves to be quoted and commented upon. It is as follows:-

" 4. The College authorities have also informed us that no LL.M. Classes are available at Shillong College. Therefore, the college is not getting qualified teachers as well. The College and the University Concerned deserve to be directed to make an attempt to start LL.M. Classes as early as possible".

This item of the report attempts to link the non-availability of qualified teachers with the non-availability of LL.M. course at Shillong. This is a peculiar argument. If the College inserts an advertisement in National dailies inviting applications from qualified teachers of Law there will be no dearth of applicants, It appears from the items 3 and 4 of the report that the college is trying to find out excuses for its failures, and putting the blame on the University.

As regards the direction of the BCI to start LL.M. course as early as possible we can also say that the BCI can only request the University in this regard. It cannot direct the University.

INSPECTION REPORT OF LAW COLLEGE SHILLONG

The Law College Shillong was inspected by the undersigned on 11.4.1998 at 5.00 P.M. in the presence of its Principal and the Accountant of the college. The college in fact was closed on that day on account of Holidays. The Principal and other staff members were present there for the purpose of inspection only.

2. The college has good building consisting of seven class rooms for the students. There were separate common rooms for the teachers and girl students. We were fully satisfied about the building of the college. The college having a presentable Library as well. So far as the teachers are concerned we were told by the Principal that there were two permanent lecturers and the remaining teachers were appointed as part-time lecturers, some of them were appointed on contract basis as well. We called for the record regarding appointment of permanent lecturers and the salary paid to them by the college. The Principal of the college produced an extract of the proceedings of the Governing body meeting held on 4-6-1997 vide which the college has decided to select and appoint Mr.K.Rehman, Mr.D.P.Chakraborty, and Mr.D.S.Virdhi as full-time lecturers on probation for two years with consolidated pay of Rs.3000/- P.M. The Principal of the college further disclosed that out of the three only two had joined the college as full-time lecturers. We the undersigned were not satisfied about the salary being paid to the full-time lecturers. We were also not satisfied with the salary which was being paid to the part-time lecturers and lecturers engaged on contract basis. As per the rules the college is supposed to pay salary to full-time lecturers according to norms of U.G.C. The Principal of the college is thus directed to pay salary to full-time lecturers as per the norms of U.G.C. grades with immediate effect. College is further directed to employ all full-time lecturers as far as possible before next session. Previously the college was inspected by Mr.Arun Mishra, Member Bar Council of India on 27.8.96. He had also directed and suggested the college authorities to follow the norms of U.G.C. so far as the salary of the lecturers is concerned. We are sorry to say that the college has not taken care of the directions given by Mr.Arun Mishra, Member Bar Council of India. But this time we want to make it clear that the college authorities should not show any slackness in complying with the direction given to them to this effect.

3. During the course of discussion it was brought to our notice that the college was originally affiliated with the Gauhati University from 1964 to 1973 and thereafter with NEHU University. It has also been brought to our notice that there is no Law Faculty in NEHU University. We understand that a University having no Law Faculty would not be in a position to set proper question papers to the Law students nor such University can provide proper syllabus to them. Under these circumstances we the undersigned further direct the college authorities to withdraw their affiliation from NEHU University and should endeavour to seek fresh affiliation either with Gauhati University or with some other University having the Law Faculty.

4. The college authorities have also informed us that no LL.M classes are available at Shillong College. Therefore, the college is not getting qualified teachers as well. The college and the University concerned deserve to be directed to make an attempt to start LL.M classes as early as possible.

AGENDA NOTE ARISING OUT OF THE AFFILIATION COMMITTEE  
REGARDING RENEWAL OF AFFILIATION OF ACHENG RANGMANPA  
COLLEGE, MAHENDRAGANJ, WEST GARO HILLS AND AIZAWL WEST  
COLLEGE, MIZORAM AND B.B.S. COLLEGE, SHILLONG.

1. ACHENG RANGMANPA COLLEGE:

Provisional affiliation for upgradation to Degree level to Acheng Rangmanpa College, Mahendraganj, West Garo Hills for three years was granted with effect from 1993 session and the letter was issued on 8th July, 1993 by the then Director, CDC. Then the college applied for renewal of extension in April, 1996 which was found to be incomplete as regards to the Fixed Deposit. Afterwards the college was pointed out about the non-fulfillment of the condition on Fixed Deposit. After subsequent reminder the college sent an SBI Receipt on Fixed Deposit for Rs. 2 lakhs dated 9.6.98. Thus there has been a lapse of more than two years for renewing the affiliation in the process. The case was put up in the last Affiliation Committee Meeting held on the 9th of November, 1998. The Committee decided to refer the case to the Academic Council for its consideration.

The case is thus put up to the Academic Council for its consideration for condonation of the delay.

2. AIZAWL WEST COLLEGE:

Provisional Affiliation was granted to Aizawl West College, Aizawl for a period of three years w.e.f. 1993 to 1996 session. The college should have applied for renewal of affiliation six months before the expiry of affiliation. After the reminder sent by the College Development Council the college sent the renewal fees only in the month of November, 1997 without sending the application format. The college was then asked to apply in the prescribed format and the application forms were received by the end of August, 1998. The case was put up in the Affiliation Committee held on 9th November, 1998. The Committee referred the case to the Academic Council for its consideration since there is a lapse of more than two years. The college also failed to apply for renewal of extension of affiliation in respect of Major in the subjects - English, History, Political Science, Education and Economics and also Mizo at General level which was also granted at the same time w.e.f. 1993 session.

The case is placed before the Academic Council for discussion and consideration for condonation of the delay.

3. B.B.S. COLLEGE, SHILLONG:

The 56th Academic Council decided that the following three conditions are to be fulfilled by the college before Provisional Affiliation is granted.

1. The college has only fixed deposit of Rs.2 lakhs as against the requirement of Rs.4 lakhs.
2. The college does not have requisite of required teachers as per norms. Specially in English, there is only one qualified teacher as against the requirement of 4(four) teachers.
3. The college does not have a regular Principal, the present Principal is a superannuated person.

At present the college has informed that a fixed deposit of Rs.4 lakhs has been kept. The college was asked to submit a certificate from the bank and it has not submitted so far.

As regards to the condition 2, the college has informed that it has two qualified teachers in each subject and 3(three) in English together with two part-time teachers from Sankardev college, Shillong.

According to the University requirements RB-2, there should be at least three teachers in each subject and four regular teachers in English. And RB-3 says, "No teacher shall be allowed to work in more than one college in the same shift".

As regards to condition 3, the college has informed that a teacher retired on 1-5-95 is appointed on contract as the Principal of the college.

The case is placed before before the August Body for discussion and consideration.

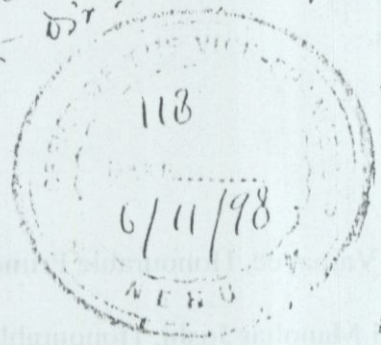

Kindly permit us to state the following few facts regarding the All India Council for Technical Education (AICTE) and MIIRD approved M. Tech. courses which the first batch (1996) has already completed and the second batch (1997) is undergoing presently (likely to complete in December 1998) in NERIST starting from 1996 and 1997 academic years respectively :

At the time of admission for the M. Tech. course in NERIST, we were registered under North Eastern Hill University (NEHU), Shillong (receipts enclosed). Since then we started devoting our time fully to the M. Tech. course with a view to brighten our prospects, assuming ourselves to be the students of NERIST under NEHU. Now the NERIST authorities are declining to provide any details of the results (Grade Cards, Provisional Certificates and Percentage Conversion Certificate) even after successful completion of the course/semesters. Now we are being told by the authorities that the M. Tech. courses have not been affiliated to any University and hence the results cannot be declared. This is surprisingly in direct contradiction to the facts we were told at the time of admission by providing the registration slip of NEHU. This has come as a great shock to us causing a lot of mental agony.

It may be pointed out for your information at this stage that the fate of the students of M. Tech. courses, who have devoted one and a half years of their precious career together with investment of a huge amount of money during this period, hangs in balance because of the pathetic attitude of the authorities concerned. It is causing a lot of mental, physical and economical harassment in running from pillar to post to know the exact status of our degrees, that is our due on the Institute. Further, the present circumstances are demoralising us as we may not be able to apply anywhere for jobs on the basis of M. Tech. degree. **It is directly hampering our prospects of employment.** This is nothing short of a gross offence on the part of the authorities concerned who are playing with the future of a large number of educated unemployed, for the upper age limit of getting jobs among many of us would have expired if we are not awarded the degree at the earliest. On the other hand, it is bound to affect the future of those sponsored candidates who are aiming to take benefit of this degree in future advancement of their professional career.

Sub: Revision of Pay scales of teachers in Central Universities following the revision of pay scales of Central Government employees on the recommendation of the Fifth Central Pay Commission.

Sir,

I am directed to invite attention to our letter of even number dated 27th July, 1998, on the above subject and to state that certain clarification in connection with the fixation of pay of certain categories of teachers have been sought from some quarters. It is hereby clarified that fixation of pay of such categories of teachers may be done in the following manner:-

1. Vice Chancellor

The revised pay scale of Vice-Chancellor will be Rs.25,000/- (fixed) w.e.f. 1.1.1996.

2. Pro-Vice-Chancellor

The replacement scale for the pay scale of Pro-Vice-Chancellor will be Rs.18,400-500-22,400 with effect from 1.1.96.

3. Principal

Those Principals in the pre-revised scale of Rs.4500-7300 will be given the replacement scale of Rs.14,300-450-22400 w.e.f. 1.1.1996 and the minimum basic pay will be fixed at Rs.15,200/- from that date. With effect from 27.7.98, the pay will be fixed in the pay scale of Rs.16400-450-20900-500-22400 starting with a basic pay of Rs.17,300/-. In the case of other Principals, the revised scale of Rs.12000-375-18000 will be given w.e.f. 1.1.96 and the minimum basic pay will be fixed at Rs.12,750/- from the date. With effect from 27.7.98 the pay will be fixed in the scale of Rs.12000-420-18300 starting with the basic pay of Rs.12,840/-.

4. Readers and Professors under Merit Promotion Scheme

The pay of a Professor under the merit promotion Scheme in the existing scale of Rs.4500-150-5700 will be fixed in the revised scale of Rs.14300-400-18300 w.e.f. 1.1.1996. The Commission may take a decision whether the Merit Promotion Scheme as it exists should continue or not after 27.7.1998.

5. Controller of Examinations/Finance Officer

The Controllers of Examinations and the Finance Officers in the Universities will be given the same pay scale as applicable to the Registrars.

6. Payment of arrear in respect of allowances other than Dearness Allowance contemplated under paragraph 1(v)(f) of the letter under reference will be admissible w.e.f. 1.8.97. Payment of Dearness Allowance from 1.1.1996 will be from the dates and at the rates as applicable to Central Government.

Subject : Revision of pay scales of teachers in Central Universities following the revision of pay scales of Central Government employees on the recommendations of the Fifth Central Pay Commission.

Sir,

In continuation of this Ministry's letter of even number dated 27.7.1998 and in supersession of the letters dated 22.9.1998 on the subject mentioned above, I am directed to say that the matter relating to revision of pay scales of University and College teachers was further considered by the Government and it has been decided to make certain modifications in the Scheme already notified by the Government vide our letter dated 27.7.1998. The modifications made in the existing scheme are as under :-

1. Pay Scales

- i) The revised scales mentioned in Annexure-I of our letter dated 27.7.98 shall be effective from 1.1.1998. Accordingly, the Annexure-II enclosed with the letter referred to may be treated as withdrawn.
- ii) The fixation of pay of Lecturers (Selection Grade) / Readers in the pre-revised scale of Rs.3700-125-4950-150-5700/- who were selected strictly in accordance with the rules and regulations framed by the UGC and who were in position as Lecturers (Selection Grade) / Readers as on 1.1.1996, will be made in a manner that they get their pay fixed at the minimum of Rs.14,940/- in the revised scale of Rs.12000-420-18300 as and when they complete five years in the grade.

Readers and Professors

The pay of Readers and Professors who were in the Pre-revised scales of Rs. 3000-5000/- and Rs.4500-5700/- will be fixed at the appropriate stage of the revised scales of Rs.10,000-325-15200/- and Rs.16,400-450-20,900-500-22400/- respectively as on 1.1.1996.

3. Pay scales of Controllers of Examination and Finance Officers

The Controllers of Examinations and the Finance Officers in the Universities will be given the same pay scale as applicable to the Registrars.

4. Age of Superannuation

The age of superannuation of 62 years indicated in para 1(vi) of our letter under reference shall also be applicable to Registrars, Librarians, Physical Education Personnel, Controllers of Examinations, Finance Officers and such other University employees who are being treated at par with the teachers and whose age of superannuation was 60 years.

5. Scheme for professional development incentives to Lecturers.

The UGC will formulate a Scheme, in consultation with the Government, for giving professional development incentives in the forms of cash allowances or assistance in kind or both to those Lecturers who register for M.Phil/Ph.D and whose pursuit of research is considered satisfactory by their guides.

6. Other terms & conditions.

The other terms & conditions mentioned in our letter dated 27.7.1998, except as modified above, will remain the same.
