

- (xi) Payment of Leave Salary and Pension Contribution in respect of Prof. M.N. Karna and release of increment - regarding.

The Executive Council vide resolution No:EC:91:96:4: (i) held on 7.12.96 resolved that Prof. Karna's case may be treated as on deputation to the Govt. of Bihar for the period w.e.f. 14.5.91 to 1.5.94 when he was absent from the University and further resolved that the refund of the L.S. & Allowances including interest may be waived as he had returned back to the University and his period of absence has been treated as on deputation. The Council, further resolved that Prof. Karna may pay the leave salary and Pension contribution due to NEHU.

Therefore calculation of L.S. and P.C. has been worked out for the period of his absence from the University w.e.f. 14.5.91 to 1.5.94 and the total amount of L.S. & P.C. calculated is Rs. 65203/-, and the penal interest for delay in payment of the L.S. & P.C. is Rs.14,879/-, for which the total amount of both the payment arrived at is Rs.80,082/-. Under Sr.307(i) contribution for L.S. & P.C. due in respect of Government servant in foreign service are to be paid annually within 15 days from the end of each financial year or at the end of foreign service if the deputation on foreign service expires before the end of the financial year. But if the payment is not made within the period, interest @ of 2 Paise per day per Rs.100/- is to be paid on the contribution unless it is specifically remitted by the President.

As the case of Prof. Karna's regularisation of the period of absence from 14.5.91 to 1.5.94 was finally decided by the 91st Executive Council, to be treated on deputation to the Govt. of Bihar, it may kindly be considered if the penal interest is to be paid by him as there is no relaxation in the Rules of the case. The delay was due to the setting up of the Committees approved by the Executive Council vide resolution No:EC:90:96:6:3(vi) to look into the case of Prof. M.N. Karna and the Council was kind enough to treat the case of Prof. Karna as on deputation, though there was irregularity on his part.

Prof. Karna has also to get the increment for the period of absence and he has requested for grant of increment but since L.S. & P.C. amount is to be paid by him to the University, his request for releasing the increment is placed to the Council.

- (viii) Distinction between Full time casual workers and part time casual workers under NEHU.

- (ix) Reimbursement of Medical expenses in respect of Mrs S Chauhan, wife of Prof Y S Chauhan, Department of Botany.

No:EC:93:97:6:6:(ix): The Council considered the grant of 100% reimbursement in respect of medical expenses incurred by Mrs S Chauhan, wife of Prof Y S Chauhan and RESOLVED that since the case was of an emergency nature the same may be sanctioned.

- (x) Rationalisation of pay scale of Assistant Press Manager.

No:EC:93:97:6:6:(x) The Council considered the rationalisation of pay scale of the Assistant Press Manager and RESOLVED that the matter be referred to the Advisory Committee for Cadre Management and the Report of the same may be placed to the Council in its next meeting.

- (xi) Payment of Leave Salary and Pension Contribution in respect of Prof M N Karna and release of increment regarding.

No:EC:93:97:6:6:(xi): The Council considered the release of increment of Prof M N Karna and RESOLVED that he should pay the leave salary and pension contribution due from him before the same can be considered.

- (xii) Effective date of appointment in respect of Shri Devesh Walia, Lecturer, Geology, PUC, Aizawl.

No:EC:93:97:6:6:(xii) The Council considered the regularisation of the past services of Shri Devesh Walia, Lecturer in Geology, at PUC, Aizawl and RESOLVED that his services may be regularised with effect from 19.12.90 only.
