

(v) Appointment of Head Department  
of History.

Prof. J.B. Bhattacharjee, was appointed as Head, Department of History, NEHU, Shillong w.e.f. 6.10.99 for a period of 3(three) years. His term will expire on 5.10.2002. But, in view of the amended Ordinance approved by the 97th E.C. vide resolution NO:EC:97:98:5:1:(v) his Headship stands automatically extended upto the end of the current semester.

ANNEXURE :- I II - MINUTES OF THE EC SUB-COMMITTEE

As per notification NO:EC:96-4/Conf/98-649 dated 2.4.98, a committee was constituted to look into the matter regarding the appointment of teachers to honorary positions. The Committee met on 1st July, 1998, deliberated on the issue and decided as follows :

(1) The members felt that if one has to do justice and devote sufficient time to discharge the responsibility of the office held, same person should not be given two or more positions/responsibilities out of the following categories:

- (i) Head of the Department/Centre.
- (ii) Dean of a School.
- (iii) Registrar
- (iv) Finance Officer
- (v) Controller of Examination.
- (vi) Librarian
- (vii) Chief Proctor
- (viii) Proctors
- (ix) Dean of Students' Welfare.
- (x) Director of Sports.
- (xi) Director, College Development Council.
- (xii) Director/Incharge, NSS
- (xiii) Director/Head, RSIC.
- (xiv) Director/Head, USIC.
- (xv) Director, Computer Centre
- (xvi) In-Charge, Campus Development Department.
- (xvii) Head/Director, State Resource Centre.
- (xviii) Director/Head, Research Centre in Bio-Sciences.
- (xix) Head, Distance Education.
- (xx) Head/Director of any other Centre/Department.
- (xxi) Pro-Vice-Chancellor.

(2) However in exceptional and emergent situation, one may be given additional responsibility of upto two positions for not exceeding sixty days. During this period, suitable arrangement should be made as per suggestions under item (1) if required.

**(i) Appointment of Head, Department of Linguistics.**

**EC:113:2002:6:2:(i):** The Council considered the appointment of Dr. Rajesh Sachdeva as Head, Department of Linguistics and RESOLVED to approve the same for a period of three years.

**(ii) Appointment of Head, Department of Anthropology.**

**EC:113:2002:6:2:(iii):** The Council considered the re-employment of Prof. BL Swer for a period of three years w.e.f. 01.01.2003 and RESOLVED to approve the same.

**(iv) Appointment of Lecturer in the Department of

**EC:113:2002:6:2:(iv):** This item was withdrawn. However, considering the HOD's letter, it was suggested that the Department might request for a temporary (ad hoc / contractual) appointment for the vacant position.

**(v) Appointment of Head, Department of History.**

**EC:113:2002:6:2:(v):** The Council considered the appointment of a Head for the Department of History and RESOLVED that Prof. DR Syiemlieh may be appointed as HOD for a period of three years. The Council, further, RESOLVED that the office should take proper care in placing the seniority list of teachers to be considered for appointments before the Council. Professor Imdad Hussain, member of the Council, pointed out that his name should have appeared at No. 1 among the Professors in order of seniority. He, however, clarified that he was not interested in the Headship and would decline, if offered.
