

- (xi) Appointment of Shri Bishnu Pada Roy as Scientific Officer, RSIC on contract basis.

The RSIC NEHU, Shillong has got the following temporary vacancies arising out of EOL/Deputation of its Scientific Officers viz:

1. Dr. Sapu Changkija - On deputation to G.B. Pant Institute of Himalayan for 3 years w.e.f. 11.11.93 (AN).
2. Shri Thomas K Job granted EOL for 3 years w.e.f. 1.1.95 to 31.7.97.

In the E.C. meeting held on 8.3.96 the Council has approved the action taken in appointing Shri B. Roy as Scientific Officer, RSIC on contract basis with effect from 28.2.95 for a period of 1 year on a regular scale of pay and for a further period of six months with effect 2.3.96 on a consolidated pay of Rs. 6000/-. As follow up of action this office had issued the appointment order for a period of 6 months w.e.f. 2.3.96. On expiry of the period the Head, RSIC vide his letter No. RSIC/SHG/Appt/96-1139 dated 31.7.96 (Annexure I) has requested for further extension of another six months with effect from 3rd Sept.'96 with one day break on 2nd. Sept.'96 and on a consolidated pay of Rs.6500/-.

The consolidated pay of Rs. 6500/- only was arrived basing on the basis pay of Rs. 2200/- and with the admissible allowance on the scale for which the total emoluments work out to Rs. 6651/- onlt.

The matter was processed by the Section and V.C. has agreed to the extension of the services of Dr. B.Roy, Scientific Officer for a period of six months with one day break on 2.9.96 with a consolidated pay of Rs. 6500/- only.

The matter is placed before the Council for ratification.

Madam,

With reference to the above, I would inform you that Dr. Bishnu pada Roy would complete his tenure as a Scientific Officer, RSIC on contract basis on 1st Sept. 1996.

Since his service are very essential, I would recommend a further extension of another six months w.e.f. 3rd. Sept. 1996 i.e. with one day break on 2nd Sept. 1996.

I would also request that his salary be on a consolidated basis of Rs. 6500/- per months.

As per the 22nd meeting of the Centre Management Committee on 20th October, 1995, on the consolidated pay of contract employees, it was recommended that the amount would be calculated on the total emoluments received on a per scale basis and should not be less than the latter.

In our letter of 3rd Feb. 1996 while recommending the consolidated pay of Dr. Roy as Rs. 6500/- since his total emoluments was coming to Rs. 6300/- +, the subsequent appointment order gave only 6000/- as consolidated. I would request that the future pay be made at Rs. 6500/- in keeping with the recommendation of the Centre Management Committee.
