

## (xi) Resignation of Prof. B. Pakem as Vice-Chancellor.

Prof. B. Pakem vide his letter No. NEHU-VCF/2-1/99-323 dated 26.7.99 (Annexure-I), submitted his resignation to the Government of India, Ministry of Human Resource Development Department of Education New Delhi, due to his continuous health problem particularly chronic Rheumatoid Arthritis which made him unable to function as Vice-Chancellor and tendered his resignation with immediate effect.

Accordingly the Deputy Secretary, Govt. of India, Ministry of Human Resource Development, Department of Education vide FAX dated 5.9.99, in anticipation of Visitor's approval requested the Vice-Chancellor to hand-over the charge of Vice-Chancellor NEHU, to Prof. K.S. Lyngdoh with immediate effect. Prof. K.S. Lyngdoh took over the charge with effect from 6.8.99.(AN). Hence, the effective date of resignation from the office of Vice-Chancellor by Prof. B. Pakem has been taken from 6.8.99(AN) with effect from the date he relinquished the Office and handed over the charge of Vice-Chancellor NEHU to Prof. K.S. Lyngdoh .

The Ministry vide letter No.F.8-24/96-Desk(u) dated 22.9.99 (Annexure-II), intimated the University that the President of India in his capacity as Visitor is pleased to accept the resignation of Prof. B. Pakem as Vice-Chancellor NEHU, in accordance with the Statute 2(a) of NEHU Act 1973 and Prof. Mrinal Miri the Senior-most Professor of the University has requested to take over charge as Vice-Chancellor until a new Vice-Chancellor assumes Office in terms of Statute 2(a)5(ii).

Prof. Mrinal Miri has taken over charge of the Office of the Vice-Chancellor with effect from 23.9.99 and notification to this effect has been issued to all concern.

The matter is reported to the Council for ratification.
