- (v) Prayer of Shri.S.R.Sen, Legal Adviser for revising the rates of fees payable to him.

Shri.S.R.Sen who is the Senior Advocate and appointed Legal Adviser of the University has submitted a request to be considered for revising the fees structure as under :-

- (a) Retainership fee from Rs.2500/- to Rs.3500/- per month.
- (b) A lumpsum fee of Rs.5000/- only for each case both in High Court and District Court which will include fees for appearance, drafting, conducting etc. 50 % of the fees to be paid at the time of appearance and filing and remaining 50 % to be paid after disposal of the case.
- (c) For drafting of each opinion, complaint etc. Rs.400/- per case.
- (d) For stationery and clerkage as per expenditure.

Shri.A.K.Phukan our Legal Adviser at Guwahati is being paid at the following rates :-

1. Retainership fee Rs.3000/- per month
2. Drafting and settling of affidavit, additional affidavit, miscellaneous petition etc. Rs.3000/- per case.
3. Appearance fees in respect of cases filed before the Principal seat at Guwahati (Civil/Criminal/Writ Petition/Writ Appeal) etc. lumpsum of Rs.10,000/- to Rs.15,000/- only depending on the nature of the case.
4. Appearance fees for conducting cases at Shillong Rs.9000/- per day/appearance.
5. Clerical expenses including certified copies or Order/ Typing/xeroxing, Court fee stamp etc. as per actual.

The present terms and conditions of Shri.S.R.Sen is enclosed as Annexure - I.

The prayer of Shri.S.R.Sen is submitted for kind consideration and decision of the Council.

In terms of E.C. resolution No.EC:104:99:6:2(xiii) passed at the 104th meeting held on 26-10-99 and No.EC:105:99:6:6(i) passed at the 105th meeting held on 9-12-99, the Vice-Chancellor, NEHU is pleased to extend the term of appointment of Shri.S.R.Sen, Sr.Advocate as Legal Adviser of the North Eastern Hill University, Shillong for a further period of three years with effect from 28-7-99 on the following terms and conditions :-

- 1) Term of extension of contract appointment : 3 (three) years w.e.f. 28-7-99 (FN).
- 2) Retainership fee : Rs.2500/- (Rupees two thousand five hundred) only per month.
- 3) Fee for drafting of deed and documents : Rs.400/- (Rupees four hundred) only in each case.
- 4) Drafting of complaints, written statement, affidavits including additional affidavits and rejoinder affidavits. : Rs.400/- (Rupees four hundred) only in each case.
- 5) Drafting and framing of rules and regulations, etc. : Amount to be accordingly decided, depending on the volume of work and its nature, with the approval of both parties.
- 6) Conducting Cases :
 - a) Civil Suits, Appeals and Revision. } according to High Court schedule of rates.
 - b) Claims in regard to tribunal cases. }
- 7) Conducting of criminal cases, appeals and revision :
 - a) According to Government rates, i.e. Rs.75/- (Rupees seventy five) only per hearing.
 - b) Adjournment, i.e. Rs.50/- (Rupees fifty) only per adjournment.
- 8) Incidental expenses towards stationery, filing, typing, xeroxing, etc. - Rs.500/- (Rupees five hundred) only in each case.

The term of appointment/engagement is terminable by either party on giving one month's notice.
