

(ii) Amendment to Clause 3(iii) of Ordinance OE -8 on qualifications for the post of Finance Officer.

As decided by the Council vide its resolutions Nos EC:99:98:5:1(vi) and No:EC:100:99:6:6:(vii) in its 99th and 100th meetings held on 8.12.98 and 16.3.99 respectively(Ref Annexure -I), the amendment to Clause 3(iii) of Ordinance OE-8 on qualifications for the post of Finance Officer, was forwarded to the Ministry for Visitor's assent.

Now, the Ministry vide their letter No.F.8-13/99-Besk(U), dated 16-9-99 as at annexure-II have advised the University to reframe the aforesaid Clause 3(iii) of Ordinance OE --8 as reproduced hereunder :-

"(a) Members of any of the Organised Central Accounts Services in the same Scale of Pay or with 5 years' service in the next below grade;

" OR "

(b) A Chartered Accountant having minimum experience of 10 years as Chartered Accountant."

In view of the above advice, it appears that the entire existing provisions of Clause 3(iii) of Ordinance OE-8 on qualifications for the post of FINANCE OFFICER, requires to be replaced by the ones as mentioned at (a) and (b) above.

The matter is placed before the Council for consideration.
