

## 6:3: Leave/Deputation.

- i) Request for extension of lien in respect of Prof.V.K.Kumar, Department of Commerce.

The Executive Council vide resolution No.EC:94:97:3:(vi) held on Sept. 23,1997, approved the grant of lien to Prof. V.K.Kumar, Department of Commerce for a period of one year w.e.f. 22.8.97 to take up an assignment at IIM(K), Calicut. On expiry of the one year period, the Council vide resolution No.EC:99:98:3(i) held on 8.12.98, approved the extension of the lien for a period of one year w.e.f. 22.8.98. Before the expiry of the 2nd year lien, Prof. V.K.Kumar, vide his letter dated August 13,1999-ANNEXURE-I, requested permission to take voluntary retirement from NEHU. The matter has been examined thoroughly and A.A.O.'s views & comments is being obtained stating that voluntary retirement while in service is not permissible under rules, and the University may consider transfer of service instead of voluntary retirement. The matter is being intimated to the Sr.Adm.Officer, IIM(K) Calicut with a copy to Prof.V.K.Kumar-ANNEXURE-II.

In view of the above letter, Prof. V.K.Kumar, vide his letter dated January 13,2000, stated that his two years lien expired on August 21,1999, and the Institute has not taken any decision about absorption. He has therefore requested for extension of another one year lien period upto 21.8.2000, to enable him to take appropriate decision. In view of the request of Dr.V.K. Kumar, the Vice-Chancellor approved that Dr.V.K. Kumar should submit an undertaking that he should either revert or resign from the parent department, within the extended period of lien, vide ANNEXURE-III. & since submitted by Prof. V. K. Kumar at ANNEXURE-IV, vide letter dt. March 6,2000.

The matter is therefore placed before the Council for decision of extension of one year lien period w.e.f. 21.8.1999.
