Dr.B.N.Saraswati was initially appointed as Visiting Professor of Anthropology, NEHU w.e.f. 19.3.1984 and on contract basis w.e.f. 19.3.1985 for one year period. In the meantime, the 49th Executive Council took a decision to appoint him as Professor under Statute-21 w.e.f. 24.1.86. His services was then placed on deputation to Indira Gandhi National Centre for Arts, New Delhi w.e.f. 21.10.1988 to 20.10.1989 for which IGNC A remitted the Leave Salary & CPF employer's share to NEHU for the aforesaid period.

Dr.Saraswati is found to be permanently absorbed in IGNC A w.e.f. 21.10.1989(FN) and tendered his technical resignation w.e.f. 20.10.1989(AN) vide enclosed ANNEXURE **A**

Therefore, to enable to process and transfer his Pro-rata retirement benefits to IGNC A, the matter is placed before the Council for kind acceptance of technical resignation of Dr.Saraswati w.e.f. 20.10.1989(AN) as requested, subject to clearance of the 3(three) outstanding books against him from the Library Department.
