

- (ii) Confirmation in respect of Dr. C. Thanthianga, Principal, Pachhunga University College.

The constituted Departmental Promotion Committee for Group 'A' category non-teaching post under Notification No.F.9-20/Estt.II/97(pt)-4181 dated 15.10.2001 met on 12.11.2001 in the Registrar's Chamber to consider the confirmation of Dr. C. Thanthianga, Principal Pachhunga University College.

Dr. C. Thanthianga was appointed to the post of Principal, P.U.C . with effect from 17.11.95 on the recommendation of the Selection Committee and in pursuance of the Executive Council in its meeting held on 4.11.95 was placed on probation for a period of 1(one) year. He has completed the probationary period and the Departmental Promotion Committee considered his case for confirmation and recommended that he may be confirmed against the post of Principal from the date of joining i.e. 17.11.95.
