

(iii) Temporary transfer of one post of Lecturer in Hindi Department to Medical Officer for processing the confirmation case in respect of Dr(Mrs) M. Marwein, M.O. -

Dr(Mrs) M. Marwein was appointed as Resident Medical Officer on the recommendation of a regular Selection Committee held on 19.12.90. She joined the University Health Centre on 24.1.91 and was put on probation for a period of two years. She has since completed the probationary period on 23.1.93 and here services are due for confirmation. As per records, Dr(Mrs) M. Marwein was appointed as Medical Officer without a sanctioned post in the grade and was temporarily accommodated against one of the vacant posts of Lecturer in Hindi Department. Her confirmation in the post on completion of the probationary period is, therefore, pending for process. The matter for creation of a post of Medical Officer was taken up with the UGC vide letter at Annexure-I but in spite of reminders by Planning Department, NEHU to the UGC, no reply has been received till date. Dr Marwein having completed more than 9(nine) years of service in the post has been pressing hard for confirmation and other benefits that would follow her confirmation, but could not be processed for want of sanctioned post.

Considering the above, the Vice-Chancellor with the consent of Hindi Department, has approved the temporary transfer of one post of Lecturer, which incidentally is being occupied by Dr Marwein. The post would be returned back to Hindi Department, on receipt of a sanctioned post of Medical Officer from UGC. In this context a letter dated 23.8.99 written by the Vice-Chancellor to the Chairman, Expert Committee is placed at Annexure-II. To expedite the case, an agenda item for creation of a one post of Medical Officer has also been taken up in the next Finance Committee NEHU meeting.

The matter is placed before the Executive Council for ratification.

Dear Prof. Tripathi,

You may recall my discussion with you regarding the abomally with regard to the present position of Dr(Mrs) M. Marwein, Medical Officer, who has been adjusted against the post of a Lecturer in the Department of Hindi. You very kindly agreed in our discussion that the Lecturer's post in the Department of Hindi, against which Dr Marwein is adjusted, may temporarily be transferred so that her position can be regularised. I had also the opportunity of discussing the matter with Prof. J.P. Singh and Prof. M.N. Karna, two other members of the Expert Committee. They have also kindly agreed to the suggestion made by me about the temporary transfer of the Lecturer's post from the Department of Hindi. I am, therefore, taking the step of transferring the post so that Dr Marwein's regularisation may take place. Meanwhile, following the discussions that I had with you and the two other members of the Expert Committee, we are taking the following steps :

- (i) Renew our efforts with the UGC for the creation of a Medical Officer's post (I am personally taking this up with the UGC);
- (ii) Take the matter to the Finance Committee for its appropriate recommendation ;
- (iii) Reporting the entire matter to the E.C. at its next meeting.
