10. (1) . Extension of deputation of Prof. (Mrs.) T. Ao, as Director, North East Zone Cultural Centre, Kohima.

Prof. (Mrs.) T. Ao's deputation term to North East Zone Cultural Centre, Kohima for a period of 4 years w.e.f. 31.8.92, approved by the Executive Council in its 84th meeting held on 8.12.94 expired on Aug.31, 1996.

The Governor of Nagaland and Manipur in his D.O. letter dt. Aug.1, 1996 addressed to the Union Minister for Human Resources Deptt., Govt. of India, New Delhi with a copy to the Vice-Chancellor, NEHU., for consideration, has stated that the Joint Secretary, Deptt. of Culture, Ministry of Human Resource, sought recommendation of names from the Executive Board of the North East Zone Culture Centre for appointment as Director.

The Governing Body and the Executive Board of the North East Zone Cultural Centre, in recognition of the outstanding performance of Dr. (Mrs.) T. Ao unanimously decided to recommend the retention of Dr. (Mrs.) T. Ao, as Director, North East Zone Cultural Centre, for another term of two years w.e.f. 1.9.96 to 31.8.98.

The Additional Secretary to Governor of Nagaland in his letter dt. 2.10.96 forwarded the application of Prof. (Mrs.) T. Ao dt. 26.8.96, requesting for extension of deputation for another period of 2(Two) years as requested by the Governing Body.

As per Appendix 5 of FR Section I, -A, Cl.8.1, the period of deputation shall be subject to a maximum of three years in all cases, except for those posts where a longer period of tenure is prescribed in the Recruitment Rules.

8.3 The borrowing Ministries/Departments may extend the period of deputation for the fifth year or for the second year in excess of the period prescribed in the Recruitment Rules, where absolutely necessary, subject to the following conditions :-

8.3(iv) The extension would be subject to the prior approval of the lending organisation of the officer on deputation, and wherever necessary.
