

- (xix) Confirmation of service of Dr. A.K. Thakur, Reader,
Department of History.

Dr. A.K. Thakur has joined this University as Reader in the Department of History on 27.12.2005 and was placed on probation for a period of one year. He has completed the period of probation on 26.12.2006 and therefore, has become due for confirmation w.e.f. 27.12.2005 i.e. from the date of joining this University.

It may be mentioned herein that Dr. A.K. Thakur, prior to joining this University was working as Lecturer in the department of History, Tirap Govt. College, Deomali, Arunachal Pradesh and in order to take up the assignment in NEHU, the Principal Tirap Govt. College, Arunachal Pradesh granted him lien for a period of one year.

As per the government of India Rule, where a Government servant is to be absorbed permanently by the foreign employer under his organization, it will be incumbent on the borrowing department to consult the parent employer before issuing orders absorbing the Government servant permanently. The order of permanent absorption should be issued only after the resignation of the government servant has been accepted by the parent organization, keeping this provision in view, a letter has already been issued to Tirap govt. College, seeking their consent in the matter of absorption of Dr. A. K. Thakur in this University. A copy of the letter issued to the Principal Tirap Govt. College, Arunachal Pradesh is placed at **Annexure-A**.

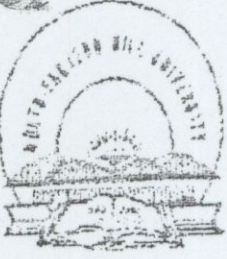
The termination of lien in the parent organization becomes automatic as and when a Government servant is absorbed by the borrowing department. So it is a matter of formality only as far as the consent of the parent organization is concerned.

In the light of the above, the Council may like to consider and confirm the services of Dr. A.K. Thakur w.e.f. 27.12.2005 subject to the condition that the order of confirmation may be issued only after the teacher concerned terminates his lien with Tirap Govt. College on submission of his technical resignation from the post held by him under the said University.
