

(iv) Appointment of Lecturer in the Deptt. of Sociology, NEHU.

The Selection Committee for the appointment of lecturer in the Deptt. of Sociology (at Annexure-I) had recommended Shri. B.F.Panda, and Smt.A.M.Mawlong in order of merit. The 112th Executive Council also resolved to approve the name of Shri Panda and Smti Mawlong. However the advertisement was made for filling only 1 (one) post. Accordingly, the 1st name in the panel Shri B.P.Panda was offered the appointment and Dr.Panda has since joined the post on 30.4.02.

Prof.A.C.Sinha, HOD Sociology, in his letter dt.30.4.02 (at Annexure-II) has stated that consequent upon appointment of Dr.A.K.Nongkynrih lecturer of the Deptt. to the grade of Reader one post of Lecturer has fallen vacant. As there is a 2nd name in panel of lecturer, the 2nd candidate in the panel may be offered the post of lecturer vacated by Dr.A.K.Nongkynrih. It may be pointed that in the case of Reader, Biochemistry 1 (one) post was advertised, where as the Selection Committee specifically recommended Dr.A.K.Singh, (Microbiology) against the advertised post and Dr.D. Syiem (Medical Biochemistry) against the vacant advertised post of Prof. in Biochemistry (at Annexure-III) and the 112th Executive Council has approved accordingly.

In the instant case of lecturer Sociology, there is however, no specific recommendation of the Selection Committee for appointment of the 2nd name in the panel against the anticipated vacancy in the lecturer post vice Dr.Nongkynrih on his appointment as Reader.

The matter is placed before the Executive Council for advice.

He, however, clarified that he was not interested in the Headship and would decline, if offered.
