- (v) Grant of lien to Dr. D. Sanyal, Sr.lecturer Horticulture, NEHU.

Dr. D. Sanyal was appointed as lecturer in Horticulture, SASRD, Medziphema on 26.8.89.

He has been confirmed in the post on 26.8.89. Consequent upon the existence of Nagaland University, he has opted for NEHU but was on deputation to Nagaland University upto 30.6.97. During his deputation with Nagaland University he submitted two applications for higher post one at Mizoram Campus for Reader in Forestry Mizoram Campus and (ii) at Visva Bharati University West Bengal. The two applications were duly forwarded by NEHU Head quarter. He was recommended and offered the post of Reader at Forestry at Mizoram Campus and had accepted the offer but requested for extension of joining time followed by commuted leave on medical ground supported by medical certificate and was considered by the Vice-Chancellor. In the meantime he received an offer of appointment as Reader, Horticulture at Visva Bharati University and accepted the same and requested to grant lien for one year and to release him with effect from 30.8.97(AN).

In view of the above, and being a permanent employee of NEHU, the Vice-Chancellor approved the grant of lien to Dr. D. Sanyal for one year with effect from 30.8.97(AN) and regularised the period of his stay at head quarter by granting him commuted leave with effect from 4.7.97 to 31.7.97 and Earn/leave with effect from 1.8.97 to 30.8.97 (AN).

The matter is placed before the Council for ratification.
