

(xv) Confirmation of Dr.Raghuvir Singh to  
the post of Professor in Physics.

Dr.Raghuvir Singh was appointed as Professor in the Department of Physics w.e.f 6.8.91(FN) on the recommendation of the Selection Committee and approval of the Executive Council resolution No.EC:73:91:08:(i) on one year probationary period. The appointment was however, subject to the final decision of the Hon'ble High Court of Civil Rule No.2593 of 1991. Dr.Raghuvir Singh has completed the probationary period of one year on 5th August 1992. His confirmation could not be ~~initiated~~ earlier as the case was pending in the High Court. The University then received the judgement of the Hon'ble High Court on 13.2.98 and the conditions laid down in the appointment order dated 21st August 1991 was withdrawn vide office order No.F.17-136/Estt.II/91-1056 dated 29.4.98 withdrawing the conditions but other terms and conditions remains the same, as per the appointment order dated 21st August 1991. The Appraisal Report of Dr.Raghuvir Singh has been received and the Head of the Department has filled in Para-F of the Factual Data part-II of the Appraisal report, for which the matter is placed to the Executive Council for confirmation of Dr.Raghuvir Singh w.e.f 6.8.91. The judgement of the Hon'ble High Court alongwith the appraisal report will be tabled by the Chair.
