Dr. B.K. Dev Sarma, Director, College Development Council, his appointment and joining to the post of Director as recommended by the Selection Committee and Executive Council vide resolution No. 91:96:6:1:(i) held on 7.12.96 has submitted an application requesting to grant him lien for a year from the Department of Mathematics.

Dr. B.K.Dev Sarma is a permanent reader, Department of Mathematics, NEHU. As per FR-13, G.O.I. order from Ministry of Human Resource Deptt of P & AR OM.No.28015 2/86-Est(i) dt. 22.7.80, retention of lien in parent department, in case of Govt. Servants getting employed in other deptts. or same deptt. their lien may be retained for a period of two years.
