

- (xviii) Appointment of Shri. P.C. Majhi as Finance Officer – deputation term thereof.

The Executive Council at its 128<sup>th</sup> meeting vide resolution No.EC:128:2007:6:2(i) considered the candidature of Shri. P.C. Mathi and resolved to appoint him as Finance Officer of the University on deputation initially for a period of three years. Accordingly, a letter was issued to Shri. Deepak Narain, Assistant Comptroller and Auditor General (Per), Office of the C.A.G. Government of India, New Delhi conveying the decision of the Executive Council on the appointment of Shri. P.C. Majhi as Finance Officer of this University on deputation term. For reference (**Annexure – A**) may kindly be seen.

In response to the letter aforesaid, Shri. Deepak Narain vide his letter dated 28.02.2007 (**Annexure-B**) placed the services of Shri. P.C. Majhi, senior D.A.G. in the Office of the Accountant General (A&E), Haryana at the disposal of NEHU for appointment as Finance Officer in the pay of Rs.16,400-22,400/- for a period of one year on standard deputation term.

On receipt of the order dated 28.02.2007 from Shri. Deepak Narain, the Registrar of the University had written a letter to him to reconsider the period of deputation of Shri. P.S. Majhi to this University for a period of three years instead of one year in consonance with the decision of the Executive Council (**Annexure-C**). Shri. Deepak Narain, Assistant Comptroller and Auditor General (Per) vide his letter dated 29.05.2007 has conveyed the approval of the Comptroller and Auditor General of India to treat the period of deputation of Shri. P.C. Majhi for three years instead of one year (**Annexure-D**). However, it has been clarified that the extension of deputation beyond the period of three years would not be permissible and the Officer concerned would be required to revert automatically to his Department on completion of the tenure of three years.
