i) Selection Committee for recruitment of teachers.

The 55th A C meeting held on 22nd and 23rd May, 1997 and 93rd E C meeting held on 15th July, 1997 has approved the panel of experts for the various Selection Committees for recruitment of teachers subject to the submission of detailed reports by the concerned Head Deptts/Centres regarding designation, scale of pay, status etc. of the experts.

In view of the above decision, the matter was referred to the Heads of deptts/centres concerned for necessary action. Now, the Head, Department of Psychology, Mizoram Campus, has submitted the panel of names of experts by indicating their designation, status, scale of pay etc. as desired by the AC/EC and some new names which do not appear in the Ist list have been incorporated in the IIInd list. Hence, the IIInd lists of experts of the Department of Psychology, Mizoram Campus is therefore, placed before the Council for favour of perusal, consideration and approval.
