

(ii) Pre-mature reversion of the services during the lien period - case of Dr.R.K. Poddar, Department of Chemistry.

Dr. R.K.Poddar, Reader, Department of Chemistry, was granted lien for two years w.e.f.24.7.98(AN) with the approval of the Executive Council in its 97th meeting held on 14.7.98 to enable him to take up an assignment as Principal SGP Poddar College. Before the expiry of one year lien period, Dr.Poddar vide his FAX Message dated 28.4.99 requested the University for permission to join back NEHU on 10.5.98.

As per Government of India orders concerning grant of lien, a Govt.servant holding lien in parent Department, should either revert to the parent Department, within the period of two years or resign from the post. The order is however silent to the effect that they should complete the period of lien granted for taking up new-assignment or pre-mature reversion to the parent Department.

The two years lien period of Dr.R.K.Poddar with effect from 24.7.98(AN) would have normally completed on 24.7.2000, but in view of his desire to return to NEHU on 10.5.99, prior to completion of the lien period, and since there is no restriction on the rules for premature reversion and considering the fact that the Chemistry Department, is understaffed, the Vice-Chancellor approved in allowing him to rejoin the Department, on 10.5.99.

The matter is placed before the Council for ratification.
