

- (ix) Ratification for release of Prof. Raghuvir Singh on lien to Delhi University, for two years.

Prof. Raghuvir Singh, Department of Physics, was granted lien for a period of two years to enable him to join as Professor of Physics & Astrophysics, University of Delhi. His application for the above post was duly forwarded by the University.

Prof. Raghuvir Singh is a confirmed/permanent employee of NEHU and has served continuously for a period of 20 yrs w.e.f 5.10.1976. The dues certificate have been received from all the concerned sections which stated that no dues are outstanding against him. The Head Department of Physics, while forwarding the application of Prof. R. Singh for grant of lien for two years has recommended the same. On the request of Prof. R. Singh, the office had allowed to retain lien for a maximum period of two yrs on the approval of the Vice-Chancellor. The same was granted to him and he was released from the University w.e.f 31.12.96, subject to ratification of the Executive Council.

As the Personal File was needed for the Court Case, the matter could not be reported to the Council for ratification of the action taken by the office.
