

(iv) APPOINTMENT OF HEADSHIP DEPTT. OF BOTANY.

The Executive Council vide resolution No. EC:97:98:3:(ii) approved the appointment of Prof.H.N. Pandey as Head Deptt. of Botany, i.e. w.e.f. 1.7.98, for 3 years and the term of his Headship will expire on 30.6.2001. In accordance to seniority and rotation Prof.R.S Tripathi would be the next seniormost teacher. However, in term of the amended Cl.(3) of Statute 7 vide resolution No. E.C97:98:5:1:(v) on the term of office of Head of Department, a teacher ceased to be Head of Deptt. on attaining the age of 60 years. Prof. Tripathi would attain the age of 60 yrs. on 7.5.2002 and could on being considered for Headship will serve only for 10 months and 7 days. Since the retirement age of teacher has been enhanced to 62 years as per the new pay Revision, the above amended Cl.(3) of Statute 7 may perhaps need further amendment in that event, the proposal of Headship in respect of Prof. Tripathi for a period of 3 yrs. would also fall short by 25 days on his attainment of 62 years on 7.5.2004.
