

- (iv) Resignation of Dr.M.Y. Khan, Reader, Department of Bio-Chemistry, NEHU, Shillong.

Dr.M.Y.Khan joined NEHU as Lecturer in the Department of Bio-Chemistry with effect from 28.6.82(FN).

He was later appointed to post of Reader in the same Department with effect from 31.3.87 and was also confirmed in the post.

During his service in NEHU, he applied for the post of Professor in Dr.R.M. Lohia Avadh University, Faizabad through proper channel and was released from the University to take up his new assignment with effect from 22.12.93 allowing him to hold lien for a period of two years with effect from the date he was released.

However, on the expiry of the lien period, Dr.M.Y. Khan submitted his representation for extension of his lien for another period of one year but the University did not accept his request. In view of this, Dr.Khan tendered his technical resignation from the post of Reader in NEHU with effect from 22.12.93(FN).

The Vice-Chancellor has approved the technical resignation of Dr.M.Y. Khan from the post of Reader, Department of Bio-Chemistry with effect from 22.12.93(FN) and released him from this date.

The matter is placed before the Council for ratification.
