

- (xvi) Appointment of Dr K. Ismail to the post of Professor in the Chemistry Department.

Dr K. Ismail was one of the candidates for the post of Professor in the Deptt. of Chemistry, for which the interview was held on 25.4.97. The recommendation of the Selection Committee was placed in the 93rd meeting of the Executive Council held on 15th July, 1997 and vide Executive Council's resolution No. EC:93:97:6:1:(ii) has resolved that for the Professor in Chemistry Deptt. (Shillong) - the recommendation cannot be opened as the matter is subjudice in the Court (due to High Court's stay order dated 10.7.97). The first judgement of the Hon'ble High Court dated 11.2.98 was received by the University and the case was dismissed with a cost of Rs.1,000/-. The writ petitioner shall pay the cost of Rs.1,000/- to the respondent No.1 and 2 within the period of two weeks from the date of receipt of this judgement through the Registrar of NEHU, Shillong. However, as the petitioner again appealed to the Hon'ble High Court in Guwahati, the final judgement was passed by the Hon'ble Guwahati High Court on 20.5.98, where the case has accordingly been dismissed. The Court has also stated that they do not propose to interfere with this imposition cost, after all the appellant is an employee of this University. We leave it to the good sense and grace of the University, whether to recover it from the appellant?

The Executive Council in its meeting held on 24.3.98 has resolved to authorise the Vice Chancellor to take appropriate action regarding the appointment of a Professor in Chemistry Department, in accordance with the order of the merit recommended by the Selection Committee. The Council also resolved to authorise the Vice Chancellor to take further necessary action on subsequent order to be passed by the Hon'ble High Court, which has fixed the case for final hearing on 26th March, 1998 or thereafter. The Council further resolved that the action taken by the Vice Chancellor in the matter be reported in the next Executive Council meeting.

(xiv) Appointment offered to Prof. KS Singh, Rajiv  
Gandhi Chair.
