

(xx) Extension of Extra Ordinary Leave to Shri A.C.Dube and request to join G.B.Pant Institute as Reader.

The Executive Council vide resolution No:EC:89:96:3:(ii) held on 8.3.96 approved the E.O.L. granted for one year to Shri A.C.Dube, Lecturer in Economics w.e.f. 1.4.96 to take up an assignment at Indian Statistical Institute, New Delhi. Before the expiry of the period of one year EOL, Shri Dube in his letter dt.19.3.97 requested for extension of the same for another period of 4 months w.e.f. 1.4.97 to complete his project at I.S.I.

The Head, Economics Deptt. forwarded the EOL application and commented as per rule. Thus, the Vice-Chancellor approved the extension of EOL for another period of 4 months w.e.f. 1.4.97 to 31.7.97.

In the meantime, Shri A.C. Dube sent another letter dt.22.4.97, stated that he got an offer to join G.B. Pant Social Science Institute, Allahabad as Reader in Economics and intends to assume the responsibilities w.e.f. 26.4.97. He therefore, requested permission to join the G.B. Pant Institute as Reader w.e.f. 26.4.97 and requested extension of E.O.L. upto 30.4.98.

In this connection, the Head of the Deptt. stated that Shri Dube did not route his application for the post of Reader through proper channel nor the offer of appointment was known to the Deptt. Thus permission to join the G.B.Pant Institute would be in contravention of the proviso of OE 6.8(ii) and EOL to join the Institute cannot be recommended for which the matter has been regretted by the University.

In view of the above, extension of Extra Ordinary Leave for 4 (Four) months to complete the project at I.S.I., New Delhi has been granted by the Vice-Chancellor with an instruction that he should resume duty immediately on the expiry of the above leave, failing which, his services is liable to be terminated w.e.f. the date of commencement of the EOL granted, in accordance with Ordinance OE 6 Cl.8(ii).

The matter is placed before the Council for ratification.

No:EC:93:97:3:(xxi): The Council ratified the action taken by the Vice-Chancellor in extending the period of deputation of Shri A .D.Sarmah,Assistant Editor and RESOLVED that no further extension will be given. Shri Atul Dev Sarmah will either have to resign or revert back to NEHU on completion of this extended term.

(xxii) Appointment of Head,Department of Forestry, Mizoram Campus,NEHU,Aizawl.
