

(iii) Resignation tendered by Dr.S.Sengupta, Reader, in Anthropology.

Dr.S.Sengupta, Reader in Anthropology, joined the University through an open selection w.e.f. 1.4.96 and is placed on a period of probation of one year.

Before completion of his probation period he tendered his resignation from the NBU vide his letter dt.27.2.97 which was routed through the HOD stating that his parent University, i.e. Dibrugarh University, has granted him one year lien to join NBU and due to household difficulties he is compelled to go back to his parent Deptt., and in view of the reasons stated Dr.Sengupta above has requested to accept his resignation from the present post and to relieve him w.e.f.1.4.97 (F/N).

"No dues certificate" have been called for and the same was received from all the concerned's sections stating that no outstanding dues are lying against him.

In view of the above, & being a temporary employee, the VC, accepted the resignation tendered by Dr.S.Sengupta and he was relieved from NBU, w.e.f. 1.4.97 (FN).
